REMARKS

On Saturday, April 2, 2016 at 21:17 hours, Officer Terribile and I Officer Ortiz were dispatched to 132 Pearl St. Middletown, Ct on a report of a disturbance.

Officer Terribile arrived before I did as he had everyone separated outside the residence. An Hispanic speaking female was observed crying uncontrollably. An Hispanic male, who was later identified by his Ct. photo identification card as, Luiz A. Gutierrez was standing outside on the front porch. Luiz appeared highly intoxicated as I spoke with him.

a Spanish speaking female, informed me (Ofc. Ortiz) that Luiz is not related to her. Luiz and

, started out drinking beers inside her apartment and as the night went by, Luiz got drunk and began yelling at her calling her a "bitch and a whore, repeatedly.

I observed Ofc. Terribile trying to get Luiz to sit down on a chair outside for his safety because he was staggering, but he kept ignoring him. I was about a foot or so away from Luiz when I heard him say in Spanish and in a low tone as he stared at Ofc. Terribile that he was going to kill him the next time he see' s him. Luiz then began to back up away from Ofc. Terribile and as he was doing so, he grabbed the front and center of his pants in a manner as to grab his penis and again in Spanish he stated, "I'm going to kick your ass." Luiz stared at Ofc. Terribile with an angry and fierce expression. I was concerned that Luiz was going to engaged in a fight with us. We were able to handcuff Luiz without incident. I then informed Officer Terribile what Luiz said in Spanish. Ofc. Terribile later told me that he thought Luiz said something threatening in nature because of the way he stared at him.

Luiz was processed and charged with, threatening (police officer) 2nd degree, 53a-62 and disorderly conduct, 53a-182. Luiz is currently being held in police lockup on \$50,000 surety bond due to the severity of this incident and threatening a police officer's life.

REMARKS

On 2/22/16 at approximately 1412hrs Officer Tyrseck responded to the area of 395 Arbutus Street for a report of ATVs and dirt bikes driving through yards. At about 1500hrs Officer Tyrseck observed two ATVs and a dirt bike driving on Millbrook Road. Two of these vehicles fled opposite her direction and a yellow

ATV being operated by a teenage male drove towards Officer Tyrseck's cruiser and then turn westbound going over someone's lawn at a high rate of speed. This yellow ATV continued to cut through resident's front lawns and drive erratically refusing to stop. Officer Tyrseck followed this ATV southbound on Millbrook Road where it was traveling above the posted limit of 25mph. She activated her overhead strobe lights and siren to let the operator know to pull over. The operator turned around and looked at her before speeding off on Livingston Road into a field. Through Officer Tyrseck's investigation, she determined that this yellow ATV was being operated by Tristan Nevins.

On 2/24/16 Nevins admitted to Officer Tyrseck that he was the one operating his yellow Honda TRX250ex on 2/22/16 driving over lawns and failing to stop for her. Nevins does not possess an operator's license, the Honda ATV he was operating on 2/22 is not insured nor is it registered.

Nevins was issued an MSC for the above charges and given a court date at GA9 for 4/7/16.





Sean stated he had thumb pain from pushing [redacted] against the wall.

I stated Sean walked by and said, "What the fuck are you looking at" and I said, "keep walking." I stated she saw Sean push I while she was in the front office. I stated she immediately left the front office and saw Sean choking with both hands up against the wall with attempting to get away. I stated Sean released his hands from I s neck approximately seven (7) seconds after telling him to stop.



REMARKS

On 4-2-16 I was dispatched to an address in Middletown for the report of a domestic violence incident. I am familiar with this address as I have responded to domestic type calls in the past at this location. This was called into dispatch by a third party on Victim 1's behalf. Dispatch told me Victim 1 was attempting to call 911 but Terrance Davis was preventing her from doing so. They also advised Davis was squeezing, throwing and shaking Victim 1's gerbils causing them to bleed. I am familiar with Davis from previous domestic issues with Victim 1 and aware that he is a convicted felon who was recently released from prison. I was aware Davis has also been previously been arrested for assaults and interfering with police. I

was advised by OFC St Peter as I was responding to the call that Davis was arrested earlier in the day for a domestic violence charge with Victim 1, and know that typically there is a full no contact conditions of release put in place by members of the Middletown Police Department when releasing someone for domestic violence charges.

Once in the apartment Davis refused my requests for him to go into the adjoining room away from Victim 1 and I. After a few requests I then advised him to go into the other room and put his hands behind his back for handcuffing. He continued to refused and I warned if he did not comply, the confrontation would become physical. He continued to refuse after at least two additional warnings. I then took control of his arm and pulled it away from his body for handcuffing causing him to fall. He was then handcuffed.

I later found evidence of the earlier arrest at the police department including a conditions of release requiring Davis have no contact with Victim 1.

Davis was charged with 54-63c violations of conditions of release and 53a-167a interfering with police on UAR # 8872845. He was given a court date of 4-4-16 at GA-09 in Middletown and held on a \$10,000.00 surety bond. See my full report for further details.
