



REMARKS

On 19 August 2016 at 0422 hours, I was dispatched to a residence for a reported Physical Fight/
 Domestic.

Upon arrival to the residence, I could hear a male voice state "I don't give a fuck" coming from an open
 window on the first floor. I then observed a white male walking inside with no shirt on who was later
 identified as David Ciezynski (21 YO) .

I knocked on the front door in an attempt to make contact with the persons within. The white male that I observed came to the door, looked out the window located at the top of the door, and stated "What do you want?" I then asked him to open the door. The male responded with "No." Just moments later, an older white male; Victim #1 opened the front door. I asked both males to step out of the residence so I can speak to them as they were both standing in the doorway, blocking it.

Victim #1 complied and stepped outside onto the front porch. Ciezynski then attempted to slam the door shut at which time I kicked the door open to prevent him from doing so. Ciezynski then started the move rapidly backwards into the residence, away from officers. Officers followed him inside and grabbed a hold of him to prevent him from fleeing. Ciezynski then began to resist and pull away from officers in an attempt to escape. Once we gained control of his arms, I placed him in handcuffs that were double-locked and check for proper fit. Ciezynski was then placed in a seated position in the hallway. At this time he was wearing nothing but a towel that was wrapped around his waist. When questioned about the incident, Ciezynski became argumentative, refused to answer questions, and continuously told us to leave his house.

After doing a further interior sweep of the residence for other possible suspects, victims or witnesses; I located Witness #1 who was laying in a first floor bedroom. Witness #1 stated that she could not see what was occurring because the bedroom door was shut, but she did hear Ciezynski and Victim #1 arguing and then what sounded like a wrestling match inside the living room just outside her bedroom door.

As I looked to the area that she was referring to, I observed that there was mail articles scattered all over the floor, the coffee table seemed to be moved out of place and there was clothing scattered throughout. I asked Witness #1 what started the altercation. She then explained that both parties were intoxicated and when Ciezynski started playing music loudly, Victim #1 told him to shut it off due to the time of night. Ciezynski became angered and an argument ensued.


I then spoke to Victim #1 who was outside. Victim #1 explained that he was sleeping when Ciezynski began playing music loudly so he got out of bed and asked him to shut it off. He then stated that Ciezynski was heavily intoxicated and started to argue with him and then push him down to the ground. At this time Ciezynski got on top of him and a brief "wrestling match" occurred. Victim #1 stated that Ciezynski did not punch or hit him with in any other manner. He stated that the altercation only lasted a few moments.

Due to the fact that Ciezynski was unclothed, he was un-cuffed and given the opportunity to get dressed. Ciezynski was given clothing and told to get dressed in the living room. He insisted that he was going to his bedroom to get dressed. He was told several times to get dressed and he became increasingly upset. Ciezynski refused and stood up aggressively and got into a fighting stance.


Officers grabbed a hold of Ciezynski. He attempted to pull away from officers and continued to fight while being handcuffed. Once he was in handcuffs officers attempted to walk Ciezynski to the police cruiser to be transported. At this time he continued to resist and attempt to pull away from police custody. Ciezynski had to be forced into the rear seat of the police cruiser.

Ciezynski was transported to police headquarters and booked and processed under UAR #8873371. He was consequently charged with CGS: 53a-182; Disorderly Conduct, CGS: 53a-61; Assault 3rd Degree & CGS: 53a-167a; Interfering with Police. Ciezynski is being held on a \$10,000 surety bond pending arraignment at GA:09 on August 19, 2016 at 0900 hours. Nothing further.






