



Operator #2 struck the left side of Vehicle #1 with the front of Vehicle #2, causing minor damage to both


vehicles and no reported injuries.

Vehicle #1 was driven from the scene by Operator #1.



On 02/05/2016, at 0145 hours the following breath test was obtained: .1854.



REMARKS

On 2/5/16, at approx.. 2008hrs, Ofc. DiMassa, Jeffries and I were dispatched to an address in Middletown for a report of a violation of a protective order/domestic. Officers were called to the same address on 2/4/16, and arrested William Davis on multiple domestic violence charges. Refer to 16-02735 for further.

On today's date the Victim stated that Davis entered their apartment through the front door. Victim said she did not say anything to him and he walked right by her, went into the bedroom and grabbed a belt. Victim said Davis then went over to their kids and said "I Love You and will see you later." Victim stated she told Davis that he was not supposed to be there. Victim stated Davis then went on a rant about how she lied to the police and he was coming back on Monday to get his stuff. Victim stated he was probably inside the apartment for less than five minutes. Refer to sworn written statement for further.

Davis was located at Main ST by Liberty ST. Ofc. DiMassa stated he saw Davis walking East on Liberty ST in the

area of the address of the Victim.

I spoke with Davis and he stated he walked by the Victims address to go to the store. He stated when he was done he walked by the address again. Davis stated he did not go inside the residence. I asked Davis where he got the belt he was wearing because he did not have one on when he was arrested last night and he stated his friend gave it to him. Ofc. DiMassa then asked one of Davis's and the Victims children if Davis was in the residence and the child stated yes.

Davis was then placed in handcuffs and transported to HQ for processing. Davis refused to be fingerprinted and was placed in an EDP cell based on his actions.
