According to Central Dispatch, the vehicle turn into the parking lot behind Arescos Market on Liberty Street in Middletown, Ct. As this officer made contact with the vehicle, the operator still parked and in the drivers seat.

The operator was identified as Colby Codraro through her suspended drivers license #198807526.

Codraro had an active warrant which she was subsequently arrested for.

The motor vehicle in question was a 2001 Honda Civic color black however the CT. registration affixed to

the vehicle was 1AVXD1 which came back on a GMC Envoy. Codraro was unable to provide this officer with valid registration or insurance documents for the vehicle. Codraro was issued an MSC #MC330236 for being in violation of C.G.S. 14-215 Operating Under Suspension, 14-213b Insufficient/no insurance and 14-147c Misuse of a Marker Plate. REMARKS


On March 8, 2016 around 0335 hours I (Ofc. Froberg) was radio dispatched to the area of Route #9 south at exit #15 for the report of a motor vehicle accident, specifically a red vehicle that had struck the center guardrail and was fleeing the scene. The reporting witness followed said vehicle, specifically a 2011


Toyota Corolla bearing CT passenger marker #8AJMG1 until which time officers were able to catch up to and stop said vehicle on Route #9 south just prior to exit #10.

Said vehicle was found to have consistent damage to the drivers side with that would have been caused by sideswiping a guardrail. A sworn statement was obtained from the witness attesting to his claims of observing the motor vehicle accident. Other officers found evidence in the area of Route #9 south around exit #16 of recent damage to the guardrail specifically some red paint transfer.

Pursuant to the investigation the operator of the evading vehicle, a Haidy Mendez appeared to be intoxicated, failed all field sobriety tests and was taken into custody for such. Mendez was tested utilizing the Drager Alcotest and found to have a B.A.C. at 0442 hours of 0.2877 and 0.2692 at 0502 hours. Mendez was issued misdemeanor summons #MC329698 for violations of CGS 14-227a Operating under the influence of alcohol and or drugs, 14-224 Evading responsibility, 14-36(a) Operating without a license and 14-230(a) Failure to drive right.

Mendez was assigned a \$5,000.00 non surety bond and released around 0545 hours with a court date of 3/18/2016 @ GA#9. Case cleared by arrest, nothing further.



On 3/10/16, at approximately 13:31 hours, I, Officer Foss-Rugan received a telephone call from Sgt. Lukanik who advised me that he received a telephone call from a local Main Street business in regards to several people drinking in public at the intersection of Main Street and Green Street. At the time, I was the north end beat officer and responded to the area.


As I approached the intersection, I observed several people standing in the area and saw a black male who I know from previous police encounters as Tyrone Taylor with a 24 ounce can of Natural Ice beer in a black plastic bag


next to him sitting on the sidewalk. Taylor is known by Middletown Officers to create disturbances and to heavily consume alcohol.

I approached Taylor and asked if the beer was in fact his which he said it was. Officer Aura Smith was request to respond to my location as my backup officer. As I continued my investigation, Taylor got very close to face and said, "yo, what's the deal?" I told Taylor to step back and extended my arm to push his chest to get him away from me. Taylor smacked my arm away from him. As I attempted to place Taylor under arrest, he resisted. Taylor held onto railings and refused to comply with my requests. As the incident was happening several bystanders crowded the scene which resulted in additional Middletown Officers responding to the area to assist.

During the time of the incident, there was multiple people walking down Main Street and driving past as the incident occurred. Taylor's behavior was alarming and disruptive to businesses and everyone in the general area.

Officer Thompson transported Taylor to Middletown Police Headquarters where he was processed and charged with Interfering with an officer (53a-167a), Breach of Peace second degree (53a-181) and 7-148/101-3- Violating a city ordinance (drinking in public). Taylor was held at Middletown Police Headquarters on a \$10,000 surety bond and was issued a court date of 3/11/16 at 09:00 hours at Middlesex Superior Court.
