REMARKS

On 03/19/2016 at approximately 1521 hours I, Officer Kraeger was stopped at a red light at the intersection of Rapallo Avenue and Main Street facing West on Rapallo Avenue.

I observed a male, who would be identified as Jeffrey Fillback walking North on the side walk of Main Street approaching the above stated intersection. I am familiar with Fillback and have dealt with him in the past. As Fillback attempted to cross Rapallo Avenue directly in front of me I observed that the crosswalk signal indicated a red hand which means, "do not cross". I pulled my vehicle forward to block Fillbacks path and stated, "wait for the cross walk signal". Fillback immediately began screaming loudly, "fuck you mother fucker". It should be noted that other pedestrians were on the sidewalk and heard Fillback yelling.

I then told Fillback to stop at which time he crossed the road yelling, "fuck you". I exited my vehicle and placed Fillback into custody for Disorderly conduct.

Fillback was transported to MPD for booking and processing. Fillback was read his rights, processed, charged with Disorderly Conduct 53a-182, Reckless use of a highway by a pedestrian 53-182, given a court date of 04/01/2016 and released on a \$1,000.00 Non-Surety bond.

Case closed.




REMARKS


