
REMARKS

Blake then made her way towards the exit of the store passing all points of purchase with no attempt to purchase the sneakers. [redacted] then left his office and apprehended Blake inside the vestibule. The total amount stolen was \$86.14. Bob's Stores wishes to pursue charges against Blake.

Blake was arrested and transported to Middletown Headquarters where she was processed and booked. She was issued a \$500 Surety Bond. Shortly after Blake posted bond and was released. She was issued a court date of September 22, 2016 at 1 Court St, Middletown CT.


