Minutes

Regular Meeting of January 26, 2023
Code Enforcement Committee

Committee Members Present: Art Higgins, Fire Marshal; Kevin Elak, Director of Health; Dean Lisitano, Chief Building Official; Gary Gessaro, Fire Marshal; Christopher Holden, Director of Public Works; Howard Weissberg, Deputy Director of Public Works; James Mastroianni, Fire Marshal; Thomas Hazel, Zoning Enforcement Officer; Lieutenant Nick Puorro; and Christopher Forte, Assistant General Counsel.

1) **Call to Order**

Assistant General Counsel Forte called the meeting to order at 9:01 a.m.

2. **Approval of Minutes**

A. Review and approval of the minutes of the January 12, 2023, regular meeting.

MOTION: Fire Marshal Higgins made a motion to approve the January 12, 2023 minutes. Fire Marshal Gessaro seconded the motion. Motion passed unanimously at 9:01 am.

4. **New Business**

A. **Mayor's Office.**

1) Update from the Mayor's Office. Absent. No updates.

1) Update from the Public Works Department. No updates.

C. **Health Department.**

1) Update from the Health Department. 486 High Street: Squatters have been located on the property and have been arrested by the Police Department. The structure has no utilities. Kevin placarded the property

and issued an order. The owner of the properties have contacted him and are working to make the structure safe. Director Elak will inform the owners that the entire structure needs to be boarded up. Will continue to monitor

D. Department of Land Use.

- 1) Update from the Department of Land Use. 35 Clinton Avenue: Fire Marshal inspected the property and found an illegal unit in the garage with a full kitchen and a tenant living on site. ZEO issued a cease and desist and will reinspect next month. Will continue to monitor.

E. Building Department.

- 1) Update from the Building Department. 248 Williams Street (Forest City Cleaner): Structure is unsafe and people are entering the property. Will connect with ECD on status of tear down of property. Will continue to monitor.

F. Police Department.

- 1) Update from the Police Department. 695 South Main Street: Hookah lounge is re-opening under new ownership. Police will inspect, and reach out to new owners. No further action needed.

5. Old Business

A. Department of Health

- 1) 460 Main Street: Reports that the owners were not making repairs to the structural foundation to the building. Sewer backup reported on site, and claims by the owner that the City is holding up work on the property. Director Holden shared that there was a letter from a structural engineer stating that the building was structurally sound. Chief Building Officer Lisitano stated that water was entering the basement through the foundation, but absent a permit pulled they have no enforcement

mechanism. Lisitano went on to state that he is aware Lenscrafters is leaving the building and when they do renovations they will need to pull permits, so the Building Department can address the water at that time. Since the last meeting Director Holden and Chief Building Official Lisitano inspected the property and found that it was structurally sound. Director Elak stated that the Health Code requires that buildings be water tight so the Health Department will inspect to determine whether any additional enforcement steps needs to be taken.

- 2) 699 Country Club Road: Reports of a structure being added to the garage illegally. ZEO has stated it does not violate zoning. Health Department stated it does not interfere with septic system. Building will follow up on enforcement of permits.

B. Department of Land Use.

- 1) 23 Silver Street: Fire at the building which is now blighted and falling down. ZEO and Fire Department have reached out to the property owner and the insurance company. ZEO contacted new owners of the property and has issued a Notice of Violation for Blight on the property for a building that has burned down greater than 2 months ago. Owner has started clearing out the property and is looking to rehabilitate the structure. Owner has approached the building department for a permit, and was informed that a report from a structural engineer will be needed. Notice of Failure to Pay Fines has been issued. Will continue to monitor.
- 2) 44-465 Middlefield Street. Letter was received from neighbors claiming that people living unlawfully at the premises, illegal dumping in the river. Police inspected and found there were no noise complaints made on the property, and there were no issues at all hours of the day when they inspected. Health department has reached out to the state to inquire about the testing of wells and was informed it was about \$400 per test. Health and Water & Sewer met regarding potential contamination and determined that only 8 houses would be at risk if there was dumping on the site. Will follow up with the mayor's office regarding testing. Will continue to monitor.
- 3) 542-544 Main Street: Reports of broken windows on the property. ZEO will inspect and follow up.
- 4) 20 White Road: Garbage and refuse located on the property. Moving forward to Citation Hearing Officer for judgment.

6. Adjournment

MOTION: Chief Building Official Lisitano made a motion to adjourn. Lieutenant Puorro seconded the motion. Motion passed unanimously at 9:22 am.
