I requested Dispatch Services conduct a inquiry through of Dragon. Dispatch Services advised Dragon had an active Warrant from this city. The warrant was confirmed by Middletown Police Headquarters.

Dragon was taken into custody without incident and transported to Middletown Police Headquarters for processing. A Record Check indicates Dragon has 2 prior convictions for Operating Under the Influence, 1 conviction of Possession of Narcotics, and 1 conviction of Drug Paraphernalia.

Dragon was charged with violating four counts of C.G.S 53a-125b, Larceny in the 6th degree. Dragon was released on a Promise to Appear and given a court date of 11/04/20 at 9:00am at GA-9. Dragon stated he understood all instructions and signed in the designated areas.

REMARKS

On 08/18/2020 at approximately 1622 HRS, Officer Nettis and I (Officer Van Almkerk) responded to an address in Middletown to investigate suspicious activity. Prior to our arrival, an anonymous caller reported seeing Mark Russo on the premises. The anonymous caller is familiar with Mark, and said he was not allowed at the above mentioned address. Dispatch advised there is a full "No Contact" Restraining Order between Mark, and the Victim. Mark is the Respondent, and the Victim is the Protected Person. Among other orders and conditions, Mark is to stay away from the home of the Protected Person. Furthermore, Mark is to stay 100 yards away from the Protected Person. Victim resides at the address in Middletown.

Upon our arrival, I located Mark in the backyard seated on a picnic table. I asked Mark to stand up, and proceeded to secure him in handcuffs. Mark said he was locked out of his residence (500 Washington Street), so he went to the Victim's residence. Mark was waiting outside of the residence because Victim was not home.

A Records Check revealed Mark has been convicted of violation of Connecticut General Statue (CGS) 14-277a Operating Under Influence, CGS 21a-279(a) Possession of Narcotics (2 Times) and CGS 21a-279(C) Possession of Drug Paraphernalia.

An

revealed no previous convictions.

Mark was charged with violation of CGS 53a-223b Violation of Restraining Order. He was held on a \$1,000 Surety Bond, and is scheduled to appear at GA9 Middletown Superior Court on 08/19/2020.
