### REMARKS

On 9/1/2020, at approx. 1939hrs, Ofc. Nettis and I were dispatched to an undisclosed address in Middletown CT for a report of a male out of control slicing his arm with a knife. The complainant stated the suspect is Craig Tsolis, and he is wearing a black t shirt and blue jeans. The complainant stated Tsolis put the knife down and has been going in and out of the front door.

Upon our arrival it was determined Tsolis was no longer in the residence. I spoke with the complainant who will be referred to as Vic #1. Vic #1 stated Tsolis has been acting crazy all day. She stated tonight he went and got a knife from the kitchen and with his left hand sliced his right forearm area. Vic #1 stated Tsolis said he was going to tell the police she(Vic #1) did it. Vic #1 stated when she called the police he left in a black Jeep Wrangler bearing CT reg . Other officers started a canvass for this vehicle. It was determined there were two Protective Orders. The first order, Vic #1 is the protected party. It stated Tsolis is to stay away from the home of the protected party which lists the address Officers were called to. Order #2 stated Tsolis is supposed to also stay away from the home of Vic #1's child which is also the residence officers were called to. It should be noted thought Vic #2 was not home during these incidents.

A short time later dispatch received a call from Vic #1 who stated Tsolis returned. Vic #1 stated he came into the

house and then left. Tsolis was arrested when he returned to the area while officers were on scene. Hunters Ambulance was called and medically cleared Tsolis and stated he did not need to go to the hospital.

Ofc. Nettis brought Tsolis to HQ where he was processed on the charge of 53a-223(3 Counts) Violation of a Protective Order. He was placed in a holding cell, held and given a court date of 9/2/2020 at 0900hrs at G.A. 9.

It should be noted that Tsolis has 10 arrests on his record and numerous pending cases for the same charges as tonight.

Officers were unable to determine probable cause for the lacerations on Tsolis's arm. Tsolis stated he was left handed and the lacerations are on his right forearm at a downward angle. It appears to be self inflicted. Tsolis was erratic when describing what happened and left the scene when he allegedly got cut and never contacted the police. He has numerous pending cases and convictions for family violence crimes and his claims don't seem credible.

REMARKS

On 08/19/20, at approximately 1857 hours, Officer Milardo and I, Officer DiFonzo, were dispatched to #37 Spring Street in Middletown CT for a motor vehicle accident complaint.

Upon arrival Officer Milardo and I met with the complainant, who was the owner of vehicle #2 (CT Registration which was parked on the right side of Spring Street (facing east bound) in front of #37 Spring Street. We also met with children's father,

stated on \_\_\_\_\_ was securing their child into the car seat in the rear driver's side of vehicle #2 when vehicle #1 (CT Registration \_\_\_\_\_ which was traveling east bound on Spring Street, when the front passenger side bumper area of vehicle #1 made contact with the rear driver's side door which was opened up. \_\_\_\_\_ stated vehicle #1 did not stop and kept traveling east bound on Spring Street and made a right hand turn onto Main Street.

\_\_\_\_\_ stated their child was secured in the car seat which was on the rear passenger side of vehicle #2. \_\_\_\_\_ told Officer Milardo and I the same series of events mentioned above by \_\_\_\_\_

Officer Miardo and I asked \_\_\_\_\_ and \_\_\_\_\_ if they and/or their two children were injured and needed medical attention, stated no.

While on scene \_\_\_\_\_ pointed to vehicle #1 which was driving by us on Spring Street headed west bound.

Officer Milardo and I made contact with \_\_\_\_\_ who was operating vehicle #1 and who also owns the vehicle. We also made contact with Elizabeth Boudah who was sitting in the front passenger seat of vehicle #1.


Officer Miardo and I informed \_\_\_\_\_ and Elizabeth of the motor vehicle accident complaint and asked them who was driving vehicle #1 earlier on Spring Street, Elizabeth stated she was. Elizabeth stated she observed the rear driver's side door open on vehicle #2 while driving by and believed she did not made contact with it with vehicle #1. Further investigation revealed that Elizabeth had a suspended CT operator's license with a suspension date of 07/02/17.


Elizabeth was issued Misdemeanor Summons and Complaint #MC455941 and a Criminal Appearance Bond for the following charges: Suspended Operator's license (14-215), Evading a motor vehicle accident (14-224) and Failure to drive right (14-230).
