

During the course of the investigation, the suspect, [redacted] was found sitting in the rear passenger seat of a 2003 Chevrolet Impala bearing CT registration [redacted]. Courtney Holmes was in the front passenger seat of the vehicle, alongside the operator, [redacted]. While Sgt. Dirga was speaking to [redacted] and Holmes, he observed what appeared to be a cylindrical glass pipe stuffed with copper wool in the center console of the vehicle. Sgt. Dirga was able to determine through his training and experience that the pipe was commonly utilized to smoke crack cocaine. A thorough search of the vehicle was conducted, which was when another crack pipe was discovered in the front right passenger door map pocket, within reach of Holmes.

Holmes was issued Misdemeanor Summons #MC807844 for violating CGS 21a-267a: Possession of Drug Paraphernalia. Holmes was released at the scene, and scheduled to appear at GA-9 on 11/08/2020 for the aforementioned offense.

[redacted] stated that when he got there I drove away but that he got her to stop after a short distance. [redacted] stated that a man was in the car with [redacted] and that the man spit on him.

[redacted] stated that he went back to 142 Lincoln street and that he started a fight with the man who had spit on him. [redacted] stated that the man threw him off of the porch at 142 Lincoln Street and [redacted] injured his leg badly. [redacted] stated that he was helpless on the ground and that the man kept punching him. [redacted] stated that the man punched him in the face about twenty times. [redacted] stated that he knows that the man's name is [redacted] and that he works at Aldi's Grocery Store in Middletown. [redacted] signed a written statement stating that he wanted to press charges.

I went to 142 Lincoln Street and spoke to [redacted] s who stated that she picked up [redacted] at his home on Rome Avenue. They were driving when they saw her ex-boyfriend, [redacted] driving. [redacted] stated that she drove to her house and [redacted] was there. [redacted] is stated that [redacted] jumped on her car and began punching [redacted] ugh the sun roof. [redacted] stated that [redacted] ot out of the car and

began punching [redacted] in the face.


I went to the Aldi's Grocery Store located at 671 Washington Street in Middletown to speak with [redacted]. He identified himself as Jukore Belin. Jukore Belin stated that he was in a car with [redacted]. Belin stated that they saw [redacted], who began chasing them. Jukore Belin stated that [redacted] pulled in front of them and forced them to stop.


Jukore Belin stated that they drove back to [redacted]'s house at 142 Lincoln Street and [redacted] was there. Jukore Belin stated that [redacted] jumped onto the car and grabbed him by the hair through the sun roof. Jukore Belin stated that he got out of the car and fought [redacted]. Jukore Belin stated that they were both throwing punches.

Jukore Belin stated that [redacted] now began pulling [redacted] by the arm. Jukore Belin stated that [redacted] was telling [redacted] to let her go but that he would not. Jukore Belin stated that [redacted] was pushing toward the rear door of the home. Jukore Belin stated that he was telling [redacted] to leave [redacted] alone. Jukore Belin stated that he finally tossed [redacted] off of the porch and [redacted] hurt his leg. Jukore Belin stated that after that they were both exchanging punches on the ground, with Jukore on top. Jukore Belin stated that [redacted] pulled him off of [redacted] and that was the end of the incident.

Victim # 1 stated that Fidalgo grabbed her wrists and started pulling her towards the rear entrance of her home. Victim # 1 stated that [redacted] told Fidalgo to let Victim # 1 go, but he would not. Victim # 1 stated that


when Fidalgo would not let Victim # 1 go, pulled Fidalgo off of the porch.



n stated that Fidalgo now began pulling Victim # 1 by the arm. stated that Victim # 1 was telling Fidalgo to let her go but that he would not. stated that Fidalgo was pushing Victim # 1 toward the rear door of the home. stated that he was telling Fidalgo to leave Victim # 1 alone. stated that he finally tossed Fidalgo off of the porch and Fidalgo hurt his leg.
