REMARKS

On 09/14/2020 at approximately 2225 hours, Officer Milardo and I were dispatched to 98 Daddario Road to investigate an a possible domestic violence incident between Nazhia Carter and

During our investigation, no evidence was developed that indicated that an active, physical domestic violence took place between the residents of #98 Daddario Rd., Nazhia Carter and Carter and live together and have a 2 year old daughter in common.

During our investigation, I had Middletown Police Dispatch run a query on [redacted] and Carter. [redacted] checked out with negative hits and Carter came back with a possible extraditable warrant out of Springfield Massachusetts. Middletown Police Dispatch contacted Springfield PD and spoke with [redacted] (fax # 413-787-6800) who confirmed that there was an active arrest warrant for Carter out of their agency for the charge of Unarmed Robbery (C265 S19(a)) under Springfield, Ma. PD case # 20-9092-0F. It was confirmed that this charge was punishable for more then 1 year.

I then confirmed Carter's identification by her Sate of Ct. Identification card #018982178 and her social security card #041-94-5310. Middletown Police Dispatch also gave us descriptor of Carter, which matched her appearance. Carter is a 20 year old black female with black hair and brown eyes. She is


approximately 5 feet 2 inches in height and weighs approximately 150 pounds

After this warrant was confirmed by _____ Sgt. Dirga contacted _____ at Springfield PD who again confirmed this Robbery warrant for Carter and that the crime was punishable over 1 year. He then gave us the name of 1st Assistant District Attorney _____ (413-505-5676) for us to contact in regards to Carter's warrant. Sgt. Dirga then contacted Inspector Fitzgerald of GA 9, Middletown to inform him of this incident.

Carter was then taken into custody for violation of C.G.S 54-169-Fugative From Justice. She was transported tom police headquarters in the rear seat of my cruiser. While at headquarters, she was searched by Officer Wade and then booked and processed by Officer Hillman under UAR #8877978. Carter was held on a \$500,000.00 for her court appearance on 09/15/2020.

There is no further information. Case closed.

REMARKS

On Tuesday 09/15/2020 at approximately 0147 hours, Middletown Officers responded to an address in Middletown for a physical domestic violence incident.

Upon arrival, We spoke with Melody Mercado who was crying inside a residence. Mercado stated she had an argument with her live-in boyfriend of two years, the victim about cultural differences which escalated to name calling before turning physical. Mercado stated the victim slapped her on the right side of her face with an open palm, so she bit the victim on the right hand to defend herself. During the investigation it was found that Mercado bit the victim twice, causing injury. She later admitted that she had lost her temper and taken it too far, but blamed her actions on being in previous abusive relationships. The victim stated he had slapped Mercado once in self defense because she was out of control and was smacking and biting him.

Mercado was held in lieu of posting the fifty thousand dollar surety bond and is scheduled to appear in

Middletown Superior Court (GA9) on 09/15/2020, 0900 hours where she will face the domestic violence charges of C.G.S. 53a-182, Disorderly Conduct and 53a-61, Assault 3rd Degree.

REMARKS

On 9/15/2020 at approximately 0242 hours, Officers responded to an undisclosed address in Middletown CT for a report of a domestic.

The investigation; to include, the verbal and written testimony of the Victim, verbal testimony of Elizabeth Shambo, visually apparent injuries, presence of a juvenile, revealed that an argument and physical

altercation ensued between the Victim and Elizabeth Shambo.

During the altercation, Shambo ripped the television in the living room and bedroom off the wall, causing damage. Shambo then threw the Victims backpack outside. When the Victim went to retrieve the item, Shambo attacked him and began to wrestle and bite him. The victim was able to get back inside the house and proceeded to the bedroom. Shambo followed and continued to wrestle him and bite him in the leg amongst other spots on his body.

A Check indicated that Shambo does not have a criminal history.

Elizabeth Shambo was booked, processed, and held on a \$50,000 bond. She is charged with the following charges; C.G.S. 53a-61 Assault 3rd, C.G.S. 53a-117 Criminal Mischief 3rd, and C.G.S. 53a-182 Disorderly Conduct. Shumbo is to appear in Middletown Court GA #9 on 9/15/2020 at 0900 hours.

REMARKS

On September 14 2020, I was dispatched an address in Middletown, on report of a domestic.

Dispatch stated the 38 year old daughter, later identified as Crystal Henderson, by CT license number 137207007, was holding a knife threatening to kill the caller, Victim 1.

Upon arrival, C Henderson did not have a knife in her possession. C Henderson stated she was upset at Victim 1 because he would not let her borrow his vehicle. C Henderson admitted to threatening Victim 1 with a knife in her hand.

I spoke to witness, I , mother of C Henderson, who provided a written statement. "On September 14 2020, I was in my bedroom with Victim 1, watching television peacefully. My daughter, C Henderson opened the bedroom door asking to use my vehicle. I responded no because she has been

drinking. This made C Henderson upset. C Henderson went into the kitchen and grabbed a large steak knife and came back into our bedroom. C Henderson told Victim 1, "I will kill you mother fucker", as she held the knife above her head. I stood between C Henderson and Victim 1 and disarmed C Henderson, while Victim 1 called the police. C Henderson has mental health issues and has been sent to the hospital by police two times this week for failure to take her prescribed medications."


I observed the knife to have an approximate 8 inch long blade. Ofc Tiano took photographs of the knife, which are attached to this case report.

C Henderson was arrested for violation of the following
CGS 53a-62 Threatening in the Second Degree
CGS 53a-182 Disorderly Conduct in the Second Degree

C Henderson was placed in handcuffs, which were double locked and checked for tightness. Ofc Wasilewski transported C Henderson to police headquarters, where she was later booked and processed. C Henderson was issued a court date of 09/15/2020, at GA 9.


