REMARKS

On 09-12-2020 at 1924 hours, I, Officer Jon Haddad, responded to 138 Broad Street regarding an evading responsibility motor vehicle accident. Upon arrival I found I waiting for me. She stated that she had witnessed the accident.

stated that she was parked on the east side of Broad Street, just north of College Street. She stated that she saw a white Hyundai drive northbound on Broad Street from College Street.

stated that she saw the Hyundai pull over to the west side of Broad Street, about one hundred feet north of her parked vehicle. I stated that the Hyundai was still facing north, but was stopped on the west shoulder of Broad Street. I stated that this looked odd because a car parked on that side of the road is normally facing south. stated that she thought that the Hyundai was actually about to pull into a driveway on the west side of the road.

stated that there was a parked car on the west side of Broad Street facing south .
I stated that it was approximately twenty feet south of the white Hyundai. I stated that
the white Hyundai then backed up quickly, and backed into the parked car's rear end.


I stated that the white Hyundai then pulled away from the collision, backed south on Broad
Street and parked on the east side of Broad Street, about thirty feet in front of her I stated
that a white male with shoulder length gray hair got out of the white Hyundai and went into 138 Broad Street.
I stated that he has not returned, and both cars are still on scene.


The white Hyundai was bearing Connecticut registration . The rear end and left rear quarter panel
did have damage that did appear fresh. The vehicle is a 2007 Hyundai Santa Fe registered to Roger
Tremblay,

The parked vehicle that stated had been hit was bearing Connecticut registration .
It is a 2019 Kia Optima registered to . The vehicle also had rear end and
left rear quarter panel damage that did appear fresh.

Approximately forty five minutes after my arrival, Roger Tremblay walked out of 138 Broad Street. I
recognized the shoulder length gray hair from the description and I approached him. Tremblay immediately
said, " I'm the guy, yes, I hit the car". When he blurted this out, he had not been questioned about the
accident. I could easily determine that he was intoxicated by his slurring his words. I did ask him if he was
intoxicated when he backed into the other car. Tremblay stated that he was sober at the time of the
accident, and that he had been inside drinking alcohol for about the last hour.

Tremblay was issued a Misdemeanor Summons # 329360 for the charges of Unsafe Backing, 14-224 and
Evading Responsibility, 14-243(b). Tremblay was released on a \$500.00 non surety bond. He was Issued a
court date of November 18, 2020 at 0900 hours. Court is GA9, located at 1 Court Street. There is also an
accident report documenting the accident on the same case number.
