Upon my arrival, Loss Prevention pointed to a male party walking away from Home Depot, which he stated was involved in the attempted larceny. That party, later identified as Darren Pelletier was detained. On Pelletier's person was 13 wax folds of Fentanyl with a total weight of 2.89 grams and 0.13 grams of crack cocaine. Pelletier was found to have an active warrant held by the Bristol Police Department.

Pelletier was charged with Conspiracy to Commit Larceny in the Sixth Degree (53a-125b/53a-48), and two counts of Possession of Narcotics (53a-279). Pelletier was released on a \$10,000 non-surety bond and turned over to Bristol PD. Pelletier is scheduled to appear at GA 9 in Middletown on 11/11/20 at 0900 hours.



Upon first contact with Victim #1, he was highly intoxicated and he even said that he was intoxicated. Victim #1 kept changing his story often but was consistent with the fact that his girlfriend, Jessica Johnson kept slapping him in the face throughout the night. They have both been arguing all night but don't remember why they were arguing.

I then went upstairs to speak with Johnson who was identified by her CT DL. I asked Johnson what happened tonight and she said that she had blacked out after the bar and didn't even know how she got home. When asked if she said any suicidal statements she wasn't sure and kept changing her story. Johnson then admitted to saying something along the lines of "I don't want to live anymore. I don't want to live while dating you." I then asked if she had slapped Victim #1 at all tonight and she said she did but did not know why she did or how many times.

Johnson had a friend over (Witness #1) was there but had since left prior to Officers arrival. Middletown

Officers spoke to Witness #1 over the phone and she said that they were both arguing all night but did not know what about. Witness #1 did see Johnson slap Victim #1 across the face at the bar and Victim #1 pushed her back. Witness #1 also sounded highly intoxicated and could not provide an elaborate or detailed story.


Based on the above facts, it was apparent that Johnson was the dominant aggressor in this incident. Victim #1 was acting in self defense.



Weselyan Public Safety was contacted and after checking their records it was confirmed that Curtis Belin had been previously trespassed from Campus.


