Brown became verbally aggressive, at this time another client at the table, _____ told Brown to stop. Brown began to threaten _____ saying he would punch him in the face, etc. and _____ noticed their communication was escalating the situation. _____ asked _____ to remove himself from the room, at which time _____ got up from the table to comply with her request. Brown stood up as well and began to "size-up" _____ and continued to threaten him. _____ eventually walked away and went to his room.

_____ said that Brown became more agitated and began to throw objects at her which included a high lighter, pen and a small cardboard box. _____ told Brown she was going to call the cops, Brown told her that he didn't care and to "fucking call the cops". She decided to walk outside to separate herself from he situation. As she was walking out the front door, Brown threw a full box of staples which struck the left side of _____ head.


I spoke to Brown, he said that when _____ told him he took too much food, which was disrespectful. He said he doesn't like when someone is disrespectful, especially a women. He also stated _____ told him to "shut up", and that's when he lost his temper. Brown said he told _____ she was going to "fuck her up" because he felt disrespected. I asked Brown if he threw anything at _____ he yes and he threw "everything" at her. He continued to make aggressive comments directed towards _____

Brown was found to be in violation of C.G.S. Disorderly Conduct (53a-182).

Ofc. Silvestrini and Ofc. Sinclair transported and processed Brown at Middletown Police Headquarters without incident. Brown is due to appear at GA09 on 11/16/2020 at 0900 hours. He was released in lieu of a \$2,000 non-surety bond pending his court date. Brown signed and stated he understood the conditions.


