REMARKS

On the above date and time, I was dispatched to 23 Hubbard St for a larceny.

Upon arrival, I spoke with V1 who stated that after meeting with his ex-wife April, he traveled to his doctors appointment that she was aware of. When he returned home shortly after, he found that the deadbolt locks to both entrance/exits to his apartment were changed. They were both installed upside down. V1 stated that he left several glass pane windows opened prior to leaving, and now all were closed and locked.

April stated that she was at the residence when V1 was at his doctors appointment, and changed both deadbolt locks. She stated that she also removed an ac unit from one of the windows, and continued to close and lock each and every window. Initially she stated that she did not have the keys to the new set of locks, but later provided them stating " I'll give them to you, if you don't arrest me."

April currently resides in Windsor CT and has not resided at Hubbard St since she vacated the property in July 2020. She stated that she is still entitled to the property and has rights to the apartment since the lease is in her name, and claims she still pays the rent. April stated that she can come and go as she pleases since she has a key to the residence.

April Islam was issued a Misdemeanor Summons (MC455277) for Criminal Lockout 53a-214 and Criminal Trespass 53a-107. Due to the domestic nature, April Islam was issued a court date of 9/29/20 at 0900 hrs. She was also issued a Conditions of Release with each and every box selected.

REMARKS

On 9/29/2020 at 0213 hours, Officers responded to the area of 460 Main Street for a Disturbance between a male and female. The female could be heard screaming in the area of a nearby construction crew; drawing their attention. This caused them to be distracted by the female screaming and public disturbance she was creating. A Middletown Police Officer who was patrolling the area at the time also could hear the female screaming.

Officers attempted to de-escalate the altercation between the two but the female party identified as Starriana Zmuda continued to yell and scream at the male party and Officer on scene. Zmuda was given multiple opportunities to lower her voice, walk away and return inside to her apartment for the night.

Zmuda was warned that she would be arrested for Breach Of Peace if she continued to scream in public and cause a public disturbance. Zmuda refused to comply with Officers demands and began shouting at a

black male MPD Officer several times "YOU STUPID FUCKING NIGGER."

Zmuda was then detained and told to put both her hands behind her back, which she refused to comply and began to actively resist. Zmuda was eventually placed in handcuffs and arrested for Breach Of Peace 2nd C.G.S 53a-181 and Interfering C.G.S 53a-167a.


Zmuda was transported to Middletown Police Headquarters for photographs, fingerprinting and given a surety bond of \$15,000.

REMARKS

Responding Officer's reported seeing the accused traveling at a high rate of speed just prior to the crash. Officer's estimated the speed to be around 80-100 MPH on Newfield Street in the area of La Rosa Lane.

This Officer determined that from the motorcycle's skid mark at the crash scene which was 145 feet long, along with the distance the motorcycle traveled after impact that the MINIMUM speed of the motorcycle would be approximately 42MPH. The speed limit in this area is posted at 35MPH.
