On Friday, 01/15/21 at approximately 1943 hours I, Officer Jeffries, responded to 29 Long Lane for a motor vehicle accident.

Upon arrival, I observed a color blue, 2019 Subaru Crosstrek bearing CT registration which had appeared to have been struck by a color white, Nissan Altima bearing CT registration /

I spoke with the operator of the Subaru, William Holder. He stated he was turning into his driveway when

the Nissan Altima struck his vehicle from behind. William stated the male driver got out of the vehicle, yelled at him and his wife, and then ran south down Long Lane. William described the male as a tall black male wearing a gray sweatshirt. William stated the male was the only occupant in the vehicle, and the male did not provide him or his wife with any required information before running away from the scene.

After an inquiry with dispatch, it was determined the Nissan Altima had unconfirmed insurance and the registered owner was listed as Rashaun Watson.


On Saturday, 01/16/20 at approximately 2100 hours, I made contact with Rashaun Watson at his home. I immediately read verbatim his Notice and Waiver of Rights, which he stated he fully understood. He signed the Notice and Waiver of Rights at approximately 2128 hours.


I asked Rashaun what happened yesterday evening involving the motor vehicle collision. Rashaun willingly admitted he was driving the Nissan Altima. He stated while driving he looked down for a second and subsequently struck the rear of the said Subaru. Rashaun stated after the collision he got out of the vehicle and began yelling at the operator and passenger of the Subaru. He stated he yelled at them out of frustration for what happened. Rashaun stated he then ran away from the scene because he was afraid and has had a lot of, "encounters" with the Middletown PD. Rashaun stated he ran south on Long Lane before hiding in the field on the west side of the street. Rashaun stated he contacted a friend who later picked him up.

Rashaun was arrested and charged for violation of C.G.S. 14-240(a), Following Too Closely, 14-213b, Insufficient Insurance, 14-224(b)(3), Evading Responsibility.

Rashaun was issued a Misdemeanor Summons (MC 808433) and was released on a \$1,500 non-surety bond. Rashaun is scheduled to appear at Middletown Superior Court (GA-09) on 04/21/21.

Nothing further.


