REMARKS

On 04/12/16 at approximately 0035 hours I, Officer Murphy was parked in a marked police cruiser in front of 222 Main St when I observed an older model Toyota driving south on Main St. with only one headlight illuminated.

I subsequently activated my emergency lights and siren prompting a motor vehicle stop at the intersection of Main St. and Union. The vehicle of concern displayed GA temporary registration GBI0051 which dispatch informed me had no record. I then made contact with operator Benonice Bank-Sotomayor who informed

me that she did not have a drivers license. Benonice did however provide a Puerto Rico drivers license with her photo as well as her birth certificate. Benonice informed me that she had recently moved to the United States and was working on receiving proper paperwork.

It should be noted that Benonice additionally failed to provide any insurance or registration information on the vehicle she was driving. Benonice stated that she recently purchased the vehicle and all of her paperwork was at home. Dispatch subsequently confirmed through a VIN check that said vehicle came back to Rhode Island and was not reported stolen. This inquiry also revealed that said vehicle had no active registration.



REMARKS

On 4/9/16 at approximately 1723hrs Officer Tiano and I (Officer Wasilewski) were patrolling the north end downtown area of Rapallo Avenue in our marked Police cruiser. As we approached the intersection of Rapallo Ave and Main Street we observed a black male, later identified as [redacted], standing on the

street corner acting nervous after we drove past. [redacted] was then seen getting into a white Ford Fusion (Bearing CT registration 862WSY). Due to [redacted] acting suspiciously, I (Officer Wasilewski) ran the vehicle registration of the vehicle he got into. Central dispatch informed me that the vehicle registration was expired as of 2/21/16. I made a U-Turn and conducted a motor vehicle stop on DeKoven Drive in the area of Washington Street.


Upon making contact with the two occupants of the vehicle I asked the driver, later identified as James White, for his license, registration, and proof of insurance. I (Officer Wasilewski) had to ask White three times before he took out his ID. When I attempted to take his ID White quickly took it away in a provoking manner preventing me from grabbing it. I also provided White numerous opportunities to provide a valid insurance and registration but he was unable to provide one. White told me if I wanted proof to "go call the insurance company".


Throughout White's interaction with this Officer, the front passenger, [redacted], attempted to reason with White and made several statements to the effect of "Just listen to them man" and "Dude just chill out."

I told White that due his inability to provide valid insurance his vehicle was going to be towed and he was going to be issued a misdemeanor summons. I told him to step out of the vehicle. White refused to step out. I told him a second time to step out of the vehicle. After the third attempt to have him step out, I tried to open the door but it was locked. I then saw White lean his body toward the center console with his body and pushed against the door as he opened it. White quickly forced the door open hitting my lower leg. White quickly stood up and aggressively stepped toward me putting his body chest to chest with mine. I extended my arm to create distance. I could see his temple and jaw tensing as he stared at me. I interpreted his actions and behavior as a threat to my safety. Before the incident became physically combative, I took White's right arm and placed it behind his back in an attempt to place him in handcuffs. White immediately tried to free himself and jerked his arm away. I pushed White against the vehicle as leverage and attempted to place him in handcuffs. White tensed his arms preventing me from being able to handcuff him. Officer Tiano came to the driver side of the vehicle and assisted in getting White's left arm behind his back, at which time he was handcuffed.

White was then transported to the Middletown Police Department where he was read his rights. Throughout the booking process White was uncooperative and refused to answer simple demographic type questions. White was charged with violation of CGS 53a-167a interfering with an Officer, 14-213b Failure to Carry Minimum Insurance, and 14-12a Operating an Unregistered Motor Vehicle. After being read his rights, photographed, fingerprinted, and processed White was released on a \$1,500 non-surety Bond. White was issued a court date of 4/26/16 at 0900hrs. It was explained to him that he would have to appear at the GA 9 Court House on that date and time.

REMARKS

On April 7, 2016 at approximately 2048 hours I (Ofc. Terribile) was walking my district in area of Main Street and Old Church Street.

At this time I noticed two (2) individuals seated in the gazebo on the South Green. As I approached announced my presence, I noticed a black female cover up an item on the bench seat. When I observed the area of the bench seat I could see three (3) "Show Cigarillos" (Cigars) outside of the wrapper. The female appeared extremely guarded and nervous. She was unable to make eye contact and became increasingly anxious. After a couple minutes of discussing my suspicion of narcotics being present, the black male stated he had marijuana on him. I requested the item several times, but never was provided the item. The male kept stating it was inside his jacket.

I requested Ofc. Del'Mauro and his Narcotic K-9 Killian to assist in the investigation.

Upon further investigating the female identified herself as Shawnay Foye. The male identified himself as

After Ofc. Del'Mauro and K-9 Killians arrival two items were located by K-9 Killian on the park bench and were identified as "PCP" (Phencyclidine). Foye admitted to being the owner of the contraband and was placed into handcuffs, checked for tightness, and double locked. Foye was then placed into the rear seat of Ofc. Tiano's Police Cruiser and was transported to Middletown Police Department for the booking process.

Once at Police Headquarters Foye was read her Notice of Rights Form, which she acknowledged by signing at approximately 2125 hours.

Both items were tested using a NARK Test Kit #10009, which tests for "PCP" (Phencyclidine) by providing the color solid blue as indicative to positive presence. After testing both items they provided positive results as indicated above. The items were placed into clear plastic evidence bags, labeled, heat sealed, and put into evidence locker #21.

Foye was then photographed and fingerprinted, which provided a Uniform Arrest #8872857 and charged with C.G.S 21a-267(d); Possession of Drug Paraphernalia and C.G.S 21a-279(b); Illegal Possession. She is scheduled to appear at G.A #9 on April 21, 2016 at 0900 hours. She was released on a \$5,000.00 Non-Surety Bond. Nothing further.

REMARKS

On 04/06/16 at approximately 0735 hours I, Officer Murphy was dispatched to the intersection of Washington and Vine St. for a report of a suspicious motor vehicle where the driver appeared to be asleep at the wheel. Dispatch added the vehicle of concern was a gray Hyundai Accent.

Upon my arrival to said intersection I recognized a vehicle matching the above description bearing CTReg#AA10479 turn left on to Washington St. and drive eastbound. The vehicle of concern then turned right onto High St. where I activated my emergency light and siren to execute a motor vehicle stop at the intersection of High St and College.

Operator Najawan Ward who was positively identified via his CT ID card stated he was coming from a friends house and admitted to being very tired from the night before. Dispatch informed me that Ward had a suspended CT Operators license as of 08/26/15. Ward stated that he was aware of his suspension and

had been recently arrested for operating under suspension.


Due to my training and experience as a Police Officer I was able to immediately identify the distinct smell of Marijuana emanating from Ward's vehicle. A cursory search of the front of Ward's vehicle revealed a cigarette box containing a green leafy substance with a strong Marijuana odor. It should be noted Ward willingly admitted to possessing Marijuana in his cigarette box.





she did get hit in the head and lost consciousness. The victim stated she woke up and saw police in her apartment.


I observed swelling on the back of the victim's head, abrasions to her forehead, and she complained of pain in her shoulder. I could see dried up blood under the nose of the victim.

Sommo had what appeared to be blood on his shoulder but no cuts or markings.


