

On 4/8/16 at approximately 1401 hours I responded to 73 Ferry Street (Corner Pocket Bar) for the report of vandalism. Officer Aura Smith also responded.

Upon arrival I spoke with the owner of the bar, He stated someone had smashed the front window of the bar. stated he wanted to press charges. He also stated a female witness say the incident. I spoke with She stated a younger looking, black male wearing a jean jacket was walking on Ferry Street arguing with an older black male. She stated she the observed the younger black male the punch the window.

I observed the window. I could see a red blood like substance on the broken glass. I asked dispatch to ask Middlesex Hospital if anyone came in for a laceration to the hand. Dispatch stated no one matching that description came into the hospital.

I photographed the damage and cleared the scene. Dispatch then informed me Middlesex Hospital called back and stated a male matching the description came into the ER with lacerations on his hand. A short time later dispatch informed me and video footage of the suspect. I placed a phone call to He stated the suspect was wearing a jean jacket, brown pants, white sneakers and had a blue

back pack.

1 stated he observed the suspect hit the window.

Upon arrival at Middlesex Hospital I was brought to the room of Lamell Swindell. Swindell stated he got into an argument with his uncle about life being difficult. Swindell stated he got so angry he punched the window of the bar. Swindell was receiving treatment for multiple lacerations to his right hand.

I issued Swindell MSC # MC 378262 for 53a-117 criminal mischief in the third degree. He was given a court date of 4/21/16 at GA09 and released on a PTA.

REMARKS

On 4/8/16 at approximately 1142 hours I was walking west across Main Street at it's intersection with Liberty Street. While walking I observed two white males sitting in front of the Soup Kitchen. I observed a male who I recognize to be Michael Twichell, attempt to pass what I believed to be a marijuana cigar to the other male. The other male saw me coming and warned Twichell the police were coming. I observed Twichell attempt to hide the cigar in his left hand.

I approached Twichell. He attempted to throw the cigar on the ground behind him. I told Twichell to stop and show me what was in his hand. Twichell opened his right hand and said "it's just a lighter". I told Twichell to open his left hand. He opened his hand and again attempted to drop the cigar. I again told him to stop and hand me the cigar, which he did.

I asked Twichell to walk to my cruiser so I could issue him an infraction for the marijuana. Once at my cruiser Twichell said "man I get a ticket for that dust". I know the term dust to be a term used for the narcotic PCP. I asked Twichell if the cigar contained PCP. He said "that's straight dust". I then informed Twichell he was under arrest. I placed Twichell in handcuffs (double locked and checked for tightness) searched his person and placed him in the backseat of my cruiser.

I transported Twichell to Middletown Police Headquarters. I weighed the PCP which revealed a weight of 0.1 grams. I tested the suspected PCP using a NARK #09 PCP Reagent. The suspected PCP tested positive. I tagged the PCP as evidence, placed it in a sealed evidence bag and placed it in evidence locker #22.

Twichell was read his rights and signed a waiver of rights form. Twichell stated he "found the blunt". He stated he thought it was weed so he picked it up and smoked it. He stated he knew from the taste that it was PCP. Twichell stated he found the cigar in different locations. When questioned about the inconsistencies, Twichell stated, a guy he knew from jail gave him the dust at Spear Park. Twichell was photographed and fingerprinted.

Twichell was charged with 21-279b Possession of a hallucinogenic on UAR # 8872859. He was given a court date of 4/19/16 at GA09 in Middletown. He was released on a \$1000 non-surety bond.

REMARKS

On 13 April 2016 at 0319 hours, I, a Middletown Police Officer was dispatched to an address in Middletown, CT. for a report of a Fight.

Upon arrival I located a black female (Victim #1) sitting outside, on the back staircase of #4 Flower Street. Also sitting with Victim #1 was Juvenile #1. Victim #1 was wearing her underwear and a shear blouse. She was visibly upset and was shaking. Due to the cold temperatures it was recommended to Victim #1 that we get out of the cold and speak inside about what occurred.

Victim #1 directed us to the second floor apartment where I spoke to Victim #1 and the accused; Denisha King (26 YO).

Initially Victim #1 was guarded and refrained from explaining what occurred. After speaking to her for a few moments, she revealed that King became upset when she found that Victim #1's daughter; Juvenile #1 urinated

on the couch. An argument then took place when King punched and scratched Victim #1 in the back. Victim #1 sustained minor red scratches to her upper back (refer to images). She did not offer any complaints of pain. Victim #1 initially stated that they were friends living amongst one another but later revealed that they were in a dating relationship.

Juvenile #1 also admitted to witnessing King strike her mother; Victim #1.

After speaking to Victim #1, I spoke to King. King revealed that she became angry when she woke up and found that Juvenile #1 urinated on her couch. She stated that her and Victim #1 argued but at no time did it become physical. I explained to her that I observed red scratch marks that appeared to be fresh. King stated that Victim #1 was crazy and she never put her hands on her. King also revealed that the two were in a dating relationship.

King has four small children that were all sleeping at the time of this incident as well as while officers were on scene. They will be referred to as Juvenile 2, 3, 4, 5.

King was transported to Police Headquarters for processing. She was consequently charged with CGS: 53a-182; Disorderly Conduct & CGS: 53a-61; Assault in the 3rd Degree. She was given a \$5000.00 Non-Surety bond and is scheduled to appear at GA:09 on 04/13/2016 at 0900 hours.


On April 12, 2016 at approximately 1924 hours I responded to 83 Santangelo Circle for a report of a domestic dispute.


