REMARKS

Pursuant to Connecticut General Statute 54-86e: The victim is a 19 year old female and will be referred to as THE VICTIM. The suspect is a 19 year old female and will be referred to as THE SUSPECT. Both THE VICTIM and THE SUSPECT informed the police that they've been involved in a dating relationship with one another for approximately 2 1/2 years and reside separately from one another.

On Wednesday, 04/20/16 at 1619 hours while in the area 170 Main Street, I saw THE VICTIM walking on the sidewalk in a southerly direction at a fast pace while immediately being pursued by THE SUSPECT who was angrily walking on the sidewalk in a southerly direction behind her. THE VICTIM appeared to be trying to get away from THE SUSPECT who was swinging her arms and was attempting to strike THE VICTIM in the back with her hands/fists.

During an interview with THE VICTIM, she stated that THE SUSPECT became jealous and angry because the back of her shirt kept riding up. She then walked out of her place of employment onto the sidewalk and THE SUSPECT followed her and was trying to hit her.

During an interview with THE SUSPECT, she stated that she was "joking around" and plays rough. While on scene, she was trying to convince THE VICTIM to say that they were "joking around."

THE SUSPECT was issued a misdemeanor summons for a violation of the following Connecticut General Statute:

53a-181, Breach of Peace 2nd Degree

She was released on a PTA with Conditions of Release - Family Violence and is scheduled to appear at Middletown Superior Court - G.A. 9 on Thursday, 04/21/16.


