REMARKS

Arraignment Report / Shoplifting Arrest:

On April 12, 2016 at approximately 14:05 hours, Ms. Corine B. Malack (age 62) was shopping at Rite Aid located at 10 Main Street. Over the course of several hours, Ms. Malack loaded her shopping cart with various items that she selected off the shelves.

Ms. Malack then proceeded to a cash register, which was located by the entrance and a cashier began to ring up said items. Note: the total estimated value of all the unpaid items in Ms. Malack's shopping cart was \$365.02.

Ms. Malack then informed the cashier that all these items have been paid for already and attempted to exit the pharmacy without attempting to pay for said items. Employees told her to stop and that they were

calling the police. Rite Aid told possession of the stolen items and Ms. Malack sat in the front of the store, to wait for the police to arrive.

During the booking process, Ms. Malack confessed to stealing said items and told the booking officer that she was going to give the stolen items to the homeless people in town as a good deed.

Ms. Malack was charged with the following violation of the C.G.S. Criminal Attempt to Commit Larceny in the 6th Degree, 53a-49 / 53a-125b. She was released on a \$5,000.00 non-surety bond and is scheduled to appear in court (GA-09) on 4/26/16 at 09:00 hours.

REMARKS

On 4/12/2016, at approximately 0347 hours I, Officer Foster, was patrolling the area of Dove Lane. I observed a red Honda CRV, bearing CT registration 0AUBM7, stopped in the roadway. A check with dispatch revealed that the vehicle's emissions were currently non-complaint as of 10/21/2015. I stopped the vehicle for the violation. I identified the operator as Anniha Valeriano by her CT Driver's License.

While speaking to Valeriano I was over whelmed by the distinct smell of an alcoholic beverage coming from her vehicle and breath. I asked Valeriano is she had consumed any alcoholic beverages this morning at which time she replied "yeah a while ago"

I asked Valeriano if she would consent to a field sobriety test and she replied "yes I guess". Valeriano subsequently failed the Horizontal Gaze Nystagmus test and refused to perform the remaining tests. The sum of all observations from the first contact with Valeriano to the time of arrest supported the probable cause for the arrest of D.U.I (C.G.S. 14-227a). Valeriano was transported to Police HQ to be booked and processed.

Valeriano was advised of her Constitutional Rights at approximately 0425 hours and at 0431 hours Valeriano denied counsel from an attorney.

I am certified in the Drager Alcotest 9510. The device was checked in accordance with the applicable state regulations.




Valeriano was given a reasonable time to make a phone call to obtain a ride home and was later released to the custody of her boyfriend. Valeriano was released on a 500 dollar non-surety bond. Valeriano was issued Misdemeanor Summons, #MC330303, and is scheduled to appear in Middlesex Superior Court on April 26, 2016 at 0900 hours.

Valeriano was also charged with violation of C.G.S. 14-164c(n) Failure to Comply with Emissions Regulations which was annotated on the Misdemeanor Summons and Criminal Appearance Bond form.
