At this time I observed a motorist pull into the Trade Winds Plaza not displaying its front registration plate as required by the State of Connecticut.




I informed Dispatch of my findings and activated my emergency lights and siren. The operator responded

to my request by pulling off and into the shoulder of the roadway on Reservoir Road near Saybrook Road.

Leary was operating his girlfriend vehicle and was unable to provide any of the proper paperwork that I requested (Insurance and Registration Information).
