REMARKS

On 07/28/2016, convicted felon Zachary Hayes (age 27) was arrested after he assaulted a City of Middletown Parking Authority employee in Mililli Plaza. Hayes struck the victim with his knee, while the victim had his back turned to him and was placing a boot on Hayes' vehicle.

Hayes then fled the scene in his vehicle after knocking the victim the to ground. This altercation was caught on surveillance camera and there were two independent eyewitnesses who saw this incident. Not to mention, Hayes subsequently confessed to the crime.

Officers located Hayes and the vehicle a short time later. Hayes was issued M.S.C. ticket # MC 379549 for the following violation of the C.G.S. 53a-181, Breach of Peace 2nd Degree. Hayes is scheduled to appear at the Middlesex Superior Court (G.A.09) on 08/17/2016 at 09:00 hours.

REMARKS

On 30 July 2016 at 1825 hours, I was dispatched to a residence in Middletown, CT. for a reported Fight between two clients whom live together. The residence is a group home that offers services to persons with mental disabilities and special needs.

Upon entrance to the residence I located a male; Victim #1 who was bleeding profusely from the top left side of his head. He was accompanied by a staff member; Witness #1. I observed a deep laceration to Victim #1's head that measured approximately two and a half inches in length and half an inch in width. The

area of the laceration was also swollen. (Refer to Images)

Witness #1 advised me that the other involved person; Lee Parise (31 YO) was on the third floor in his bedroom. Officers located him and he was detained without incident.

I then spoke to Witness #1 who observed the incident take place. He stated that Victim #1 and Parise share a room and they often get into arguments.

Witness #1 stated that this incident started when Victim #1 was on the stairs and Parise pushed him from behind. Witness #1 then explained that Victim #1 turned around and a physical altercation ensued on the second floor landing in which both parties began pushing and throwing punches at one another. The altercation led into the bathroom where Parise pushed Victim #1 into the bathtub causing him to fall. Witness #1 believed that this is when Victim #1 sustained the head injury.

Victim #1 was transported to Middlesex Hospital by Hunters Ambulance for medical treatment.

In addition to the head injury, Victim #1 also complained of pain to his upper right arm. I did not observe any visible physical injury to the area.

The staff at the group home advised me that both individuals suffer from mental disorders.

A check of Parise's CT Operators License revealed that he had an active Warrant out of New Haven, Connecticut.

When I spoke to Parise, he admitted to becoming frustrated with Victim #1 and also admitted to attacking him. Parise stated "once I started hitting him I could not stop."

Parise was transported to Police Headquarters where he was booked and processed under UAR #1802499. He was consequently charged with CGS: 53a-182; Disorderly Conduct & CGS: 53a-61; Assault 3rd Degree. Parise was released on a \$10,000 non-surety bond into the custody of New Haven Police Department. He is scheduled to appear at GA:09 for arraignment on August 01, 2016 at 0900 hours.

Parise was issued a Conditions of Release Family Violence form with all boxes checked which he acknowledged by signing.

REMARKS

On 7-29-16 at 17:02hrs a young female, who will be referred to in this report as Victim #1(VI1), came in the Middletown P.D to report a past domestic dispute. The offender will be referred to in this report as (OF1). VI1 would later give a sworn written statement to this officer which detailed the following events.

VI1 stated that she was attempting to leave her residence in her car when OF1 came

out and forcible attempted to grab the keys from her. At one point a struggle ensued between the two and OF1 grabbed VI1 by the throat. During the struggle VI1 sustained minor injuries that did not require medical attention.

These officer would later located a highly intoxicated OF1, who refused to give any information about the incident. OF1 was subsequently placed under arrest and transported to the Middletown P.D where he was processed for the charges of 53a-182 Disorderly conduct, 53a-61 Assault 3rd, and 53a-96 Unlawful restraint 2nd.

OF1 was held on a \$50,000 Surety bond and given a court date of 8-1-16 End

REMARKS

This incident is a violation of a protective order between a female and Antonio Rogers. The female is the protected person and Mr. Rogers is the SUSPECT in this incident. Hereinafter, the female will be referred to as Victim #1.

On Sunday, 07/31/16, Detective Derek Puorro and I, Officer Jeffries responded to a location in Middletown for a police assist. Victim #1 called 911 stating her ex-boyfriend, Antonio Rogers has been contacting her via text message and she has a no contact protective order in place.

Prior to my arrival, Detective Puorro was on scene when Antonio called Victim #1's cell phone.

Upon arrival, I spoke with Victim #1 and she showed me text messages from telephone number, 860-797-4647, which is Antonio's cell phone.

Victim #1 admits she continually contacts Antonio with phone calls and text messages.

I contacted Antonio at the above telephone number and he admits he contacted Victim #1 but stated Victim #1 keeps contacting him. I explained to him he was in direct violation of the protective order, which Victim

#1 had in her possession. I read to Antonio verbatim the terms and conditions of the protective order. Antonio continued to tell me he did nothing wrong and eventually hung up the phone.

At approximately 0130 hours, Antonio contacted me. I explained to him he needs to turn himself in for violation of a protective order and if not, I would apply for an arrest warrant.

At approximately 0200 hours, Antonio contacted me again stating he would like to turn himself in. At approximately 0220 hours, I arrested Antonio Rogers at the intersection of East Street and Town Colony Drive for violation of C.G.S. 53a-223, Violation of a Protective Order.


Antonio was transported to the Middletown Police Department. He was afforded to make a telephone call. He was booked, processed, placed in holding cell #4, and was held on a \$10,000.00 non-surety bond.


While processing Antonio, he told me if the police did not take care of this situation then he would take care of it himself. He provided no plan or further information.
