On 8-22-16 at 1734 hours, I was dispatched to the intersection of Windy Hill Rd and Saybrook Rd for an intoxicated male that was sitting on the side of the roadway, drinking from a bottle of alcohol, and unable to stand.

Upon arrival on the scene, I observed Mr. Wilson sitting on the lawn of 9 Windy Hill Rd. He was intoxicated and had an open 40 ounce bottle of Budweiser Beer in his lap. He stated that he was sitting there reminiscing about his accident at that intersection from three years ago.


I asked for his identification. He stated that he didn't have one. I asked for his name and he told me that he didn't have to tell me. I explained that he was on the complaint's property drinking in public. He told me to "go fuck myself!". I again asked his name and he stated Don Wilson. I asked his address and he again told me to "go fuck myself!" I asked his date of birth and he told me that he didn't have to tell me and that I

am a "fucking asshole" for bothering him. I explained that he could be arrested for interfering with my investigation and he stated that he "doesn't fucking care!"

I told him to stand up. He could not without falling over. He took a step towards me in an aggressive manner and Officer Delima and I handcuffed him and placed him into my cruiser. I then summoned an ambulance for detox.

I confirmed his name and date of birth with a DOC picture. He was then released to Hunter's Ambulance for detox on an MSC for Interfering With An Officer, Simple Trespass, and VCO Drinking In Public with a court date of 9-7-16 in GA 9.

**REMARKS**



Mr. Carey stated that the vehicle was not insured and that his license was suspended. A records check showed that his license was suspended as of 3-26-14.



**REMARKS**

On 08/27/16 I, Officer Ortiz was working a bar detail at Mezzo's bar located at 106 Court Street along with fellow officers Remotti and Puorro.

Approximately 1:05 hours, the aforementioned officers observed a white male being escorted out of Mezzo's bar by the bouncers because he was causing a disturbance, fighting and throwing beer bottles. The suspect left the area and began walking around the exterior of the building and toward the rear. The suspect climbed a 6 foot chained linked fence that leads to the bar. The suspect made his way down a set of stairs and back into Mezzo's. The suspect was escorted out of the bar a second time by the same bouncers. The suspect appeared highly intoxicated. The suspect was placed in handcuffed by Officer Remotti and advised he was being detained.

The suspect told Officer Remotti that his identification was inside his wallet. Officer Remotti removed his wallet from his pant pocket and remove the only identification that was inside. The identification was a Ct photo driver's license issued to 24 year old

After viewing the drives license carefully, I (Ofc. Ortiz) noticed the features on the drivers license were different then the suspect. I informed the suspect that the license he had in his wallet was not his, however, he insisted that he was . I then spoke with an unidentified friend of his who was waiting to take him home. When asked, he told me his friend's name is Anthony Nicoletti and that he's 19 years old.

The suspect lowered his head and said that he was sorry he lied about his name. He told me his real name is Anthony N. Nicoletti and that he was 19 year's old. He was later positively identified by his Ct drivers license #079028029 which was located in his vehicle. Anthony said he used the license to get into Mezzo's.

Anthony was advised that he was under arrest and advised of his Miranda rights. Anthony was transported to police headquarters and processed on the following charges, criminal impersonation 53a-130, improper use of a license 14-147(c) and creating a public disturbance 53a-181a. Anthony was issued a court date of 09/08/16 to appear at GA9. Anthony was released from police lockup on a \$2500 non -surety bond. He was released to his mother,

REMARKS

On the above date and time, this officer was traveling north on Saybrook Road, Middletown CT in the area of Tryon ST in a marked Middletown Police cruiser. Directly in front of this officer was a white Toyota Camry bearing CT Reg. 323MMZ. The Camry was traveling at approx. 20 MPH in a 45 MPH zone. The vehicle was occupied with 3 parties and had no hazard lights on and was showing no signs that the vehicle or operator was in distress.

This officer ran the registration through central dispatch at which point it came back as a 2001 Hyundai

Odyssey. The vehicle in question was a Toyota, not a Honda. This officer initiated a motor vehicle stop in the area of Tryon ST and Sandhill RD. Upon the stop, the driver was identified as a 15 year old juvenile who was the child of the front passenger and owner of the vehicle.


This officer identified the owner as Andrew Smikle, CT OLN 056694046. Smikle was unable to provide this officer with any documentation showing registration or insurance of the vehicle. Smikle stated that he was just teaching his daughter how to drive. This officer informed Smikle that until his daughter possessed a valid learners permit, she could not operate a motor vehicle.

Smikle was issued an MSC #MC455200 for being in violation of CGS 14-147C, Misuse of a Marker plate, 14-213b No Insurance and 14-12a\* Operating an Unregistered Motor vehicle. Smikle was given a court date of September 1, 2016 GA9. 1 Court ST. Middletown, CT 0900 hrs.

Smikle's vehicle was towed by Midtown Towing to his residence.


