

The victim reported that he had a Echo brand weed whacker valued at \$200.00 stolen out of his backyard. A resident of Bacon Avenue reported to the police that a Hispanic male wearing black shorts and a black t shirt was in his neighbors backyard and told him that he was looking for tools that were stolen from him earlier in the day. The resident told the Hispanic male to leave the area.

Officers began canvassing the immediate area. During the course of the canvass, Sgt. Baboolal located two males at the corner of Grand Street and Bacon Avenue looking at a clothes dryer. 

On 8/8/16 at 1341 hours this Officer was dispatched to 200 Main St. Metro square on the report of an intoxicated person. As I was pulling up to that location I heard Officer Liistro call out on the radio but couldn't hear what he said because of a woman screaming in the background. When I arrived I observed Ofc. Liistro restraining Marilyn Sweatt. As I walked up she was physically struggling with Ofc. Liistro; screaming and swearing at him. She kept repeating "you grabbed my wrists you fucking asshole for walking on the side walk fuck you." I assisted in placing Sweatt in the rear of my marked patrol car.

I then spoke to the complainant who is the property manager for Metro Square. stated that this is a continual problem with vagrants loitering on the property and drinking. He stated he has numerous complaints from tenants and customers about the "homeless" people hanging out and drinking. He stated that maintenance has informed him that people are urinating on the bushes and defecating as well. Ofc. Liistro stated to me that when he arrived he told Sweatt four times that she needed to leave the property. Ofc. Liistro stated that she got in his face and began to scream obscenities at him. Ofc. Liistro stated he was concerned because there were so many patrons walking up and down the sidewalk at this time of day. Ofc. Liistro stated that Sweatt became so combative that he grabbed her by the wrists and placed her in handcuffs. I took a sworn written statement from stated that he was contacted by the security guard for Metro Square that there were 3 men and 1 woman drinking on the property refusing to leave.

stated that when he arrived the men left but the woman refused. She began to scream and swear at him causing a scene. stated that he saw Ofc. Liistro on his patrol beat across the street and was able to flag him down. stated that he wants Marilyn Sweatt arrested for what she has done. stated that she is not welcome back and if she returns he is requesting her arrest. Marilyn Sweatt was transported to the Middletown Police Department where she was processed on the charge of Breach of Peace 53a-181. She was given a court date of 8/9/16 at 0930 hours and held on a \$2500.00 surety bond. End of report.



**REMARKS**

On 08/02/16 this officer was traveling west on Washington Street in the area of Butternut Street. I observed traffic stopped in the left lane for a vehicle turning left across traffic. 


