REMARKS

On 2/10/16 at approximately 2051hrs I (Officer Wasilewski) was traveling southbound on Main Street when I observed two vehicles (Chevy Malibu and Jeep Grand Cherokee) traveling at a high rate of speed in a possible road rage incident.

In the area of Ridge Road, the Malibu drove over the double yellow line and proceeded southbound in the northbound lane, passing the Jeep Grand Cherokee. Both vehicles then sped southbound from Main Street Extension into Saybrook Road. The Malibu again passed a vehicle in the wrong lane by the intersection of

Main Street Extension and East Main Street. The Jeep drove by that vehicle on the right side in a right hand only turn lane, then proceeded straight onto Saybrook road behind the Malibu. It was then apparent this incident was turning into a road rage type situation.

I activated my overhead emergency lights and siren then accelerated toward the two vehicles traveling southbound on Saybrook road. Both vehicles were traveling approximately 55 mph in the 30 mph zone. The two vehicles came to a stop in the area of 60 Saybrook Rd. When I exited my cruiser to make contact with both operators, the first vehicle (Chevy Malibu) drove off. I activated my cruiser siren and horn several times but the vehicle did not pull back to the side of the road.

I then proceeded southbound toward the Malibu with my emergency lights and siren activated. The Malibu was clearly accelerating to get away as quickly as possible. It was not until approximately 1.07 miles down the road (according to Goodle Maps) that I caught up to the vehicle in the area of the Citgo Gas Station on Saybrook Road (649 Saybrook Rd).

The Malibu pulled into the Citgo Gas Station and stopped in one of the parking stalls. I approached the driver side and made contact with the operator () stated he was unsure if I was originally stopping him or the Jeep Cherokee. I asked him why he didn't remain stopped where he was if he was unsure. \ maintained that he did not know I was trying to pull him over. \ did however admit that he was driving recklessly and made several dangerous maneuvers with his vehicle such as passing the Jeep in the northbound lane.

I was issued a misdemeanor summons (MC 330224) for violation of CSG 14-222 Reckless Driving and 14-232(b) Unsafe passing. He was given a court date of 2/23/16 at 0900hrs and told he would have to appear at the GA 9 court house on that date and time. He stated he understood.

REMARKS

On 2/9/16 at approximately 2247hrs I (Officer Wasilewski) was dispatched to a motor vehicle accident in the area of 6 Hillside Court. Central dispatch informed me that one of the vehicles had reportedly fled the scene of the accident. It was described as a maroon 4 door sedan, possibly a Chevrolet Impala. It was last

seen heading westbound on Hillside Avenue toward East Main Street.

Upon my arrival I spoke with the owner of the struck vehicle, as well as one of the next door neighbors who stated they both saw the vehicle flee the scene. The owner (later identified by his CT driver's license as _____ n) stated he and his neighbor both heard a crash outside. He went outside and observed a dark red/maroon vehicle bearing CT registration flee the scene. The vehicle was a red Dodge Intrepid found to be registered out of 198 Rose Circle.


I arrived at Rose Circle and observed the vehicle parked on the side of the road of Rose Circle with matching damage. There were also two empty "nippers" of Captain Morgan outside the vehicle and on the floorboard. Officer Silvestrini went to the address and spoke with the registered owner of the vehicle. She informed Officers that her son, Shawn Statkiewicz was driving the vehicle a short time earlier and was currently "Drunk as a skunk". We then spoke with Shawn in the basement. Shawn admitted to driving the vehicle, being drunk, and fleeing the scene of the crash. He was at the scene because he was "trying to give his girlfriend a Valentines Day Gift" who lived at Hillside Ct.

At the Middletown Police Station, Shawn Agreed to take the breath test. His first test registered a blood alcohol content of .2881, over three and a half times the legal limit. Shawn's second test registered a .2795 blood alcohol content.


Shawn Statkiewicz was charged with Driving Under the Influence 14-227(a), Evading a Motor Vehicle Accident 14-224a, and 14-13 Failure to Carry Insurance. He was issued Misdemeanor Summons number MC 330234 and given a court date of 2/26/16 at 0900hrs. Shown was told he would have to appear at the GA 9 Court House on that date and time. He was released on a \$500 Non-Surety Bond.

Shawn Statkiewicz has prior convictions for Illegal Possession of a Weapon, Three prior DUI's (Not including most recent two DUI's on 2/5/16 and 2/9/16), Assault 3rd x2, Assault 2nd, Disorderly Conduct x5, Violation of Probation, Violation of Restraining Order, and Reckless Driving.

REMARKS

On Thursday, 02/11/16 at 2114 hours, I saw a black Audi traveling south on Old Mill Road and was approaching the four-way intersection at Walnut Grove Road and Belvedere Drive. The black Audi then failed to stop for the stop sign at this intersection and continued to proceed south on Old Mill Road. This stop sign is clearly visible and can be seen from a distance of more than 100 feet prior to approaching this intersection.

I conducted a motor vehicle stop of the Audi CT 8ARGD9 on Old Mill Road, approximately 500 feet south of the above intersection. MPD Central Dispatch reported that this license plate was listed to a 1998 Lincoln Navigator out of Prospect, CT, and not an Audi.

The male operator of the vehicle was informed of the stop sign violation (C.G.S. 14-301), and was asked to produce his driver's license, vehicle registration, and insurance I.D. card. He was positively identified with a State of Connecticut I.D. Card (219014729) as DONELL LEWIS.

MR. LEWIS was unable to produce a valid driver's license, registration and insurance I.D. card. He indicated that he was in the process of conducting such business with the DMV.

An inquiry with MPD Central Dispatch determined that MR. LEWIS did NOT have a Driver's License issued to him, only an I.D. card.

MR. LEWIS was found to be in violation of the following Connecticut General Statutes:

- 14-301, Failure to Obey Stop Sign
- 14-36(a), Operating without a Driver's License
- 14-12(a)*, Operating an Unregistered M/V
- 14-213b, No Insurance
- 14-147, Misuse of a Marker Plate

He was issued misdemeanor summons' (MC397169 & MC397170) and is scheduled to appear at Middletown Superior Court - G.A. 9 on Wednesday, 02/24/16.



REMARKS

REMARKS

On 2/11/2016, at approximately 0119 hours I, Officer Foster, was parked on Main Street observing traffic for motor vehicle violations. I observed a vehicle traveling with a defective brake light at which time I initiated a motor vehicle stop for the violation. I approached the operator on the driver's side and identified her as Melanie Badin by her Connecticut Driver's License.

While speaking to Badin, I observed that her eyes were bloodshot and her speech was slurred. I could smell the strong presence of an alcoholic beverage emanating from Badin's vehicle and breath. Prior to having Badin exit the vehicle, I requested that she recite the alphabet from the letter F to S. Badin stated that she knew the alphabet, however, recited the letters "B,U,R,S" in that order. Badin looked at me and stated, "I can't do it".

I asked Badin to turn off her car and exit the vehicle. I asked Badin if she would consent to a Standardized Field Sobriety

Test and she stated, "Yes, I'm sorry". Badin subsequently failed to perform the SFST to standard. The sum of all observations from the first contact with Badin to the time of arrest supported the probable cause for the arrest of D.U.I.

I am certified in the Drager Alcotest 9510. The device was checked in accordance with the applicable state regulations.



Stephens was cooperative and stated he had a firearm holstered to his right hip and he has a pistol permit. The handgun was secured by officers.






