**REMARKS**

On 07/18/16 at 1142 hours this Officer was dispatched to 834 Washington St. on the report of a stolen motor vehicle. Upon arrival I spoke with [redacted] stated that while he was about to back out of the parking stall in front of the bank a white male in his late teens knocked on his window. [redacted] stated that the young man began to ask questions about the vehicle and asked if he would consider selling the car. [redacted] stated that the young man told him he would give him \$5000.00 for the car he just wanted to test drive it. [redacted] stated that he asked the young man to show him some identification. [redacted] stated that the young man showed him a CT. Driver's license with the name [redacted] of East Hampton CT. At this time [redacted] stated that he exited the driver's seat and walked around the back of the vehicle. [redacted] stated as he attempted to enter the passenger's side of the vehicle the white male threw the car in reverse and spun the tires as he sped away. [redacted] stated he was screaming stop stop what are you doing where are you going. [redacted] stated that he watched his vehicle drive away; he then went into the bank and called 911 to report the theft.

[redacted] described the suspect as a white male in his late teens early twenties with a red shirt that had the Turkish symbol on it and the male was in possession of a back pack.

At approximately 1330 Officer Thompson transmitted over the police radio that he had located the car occupied in the rear of 834 Washington St. behind the Laundromat. Ofc. Thompson requested additional units at this time. A short time later this Officer arrived at the Laundromat. It was at this time the suspect was identified as Kubilay Demirhan who is known to this Officer from previous interactions.


[redacted] was notified immediately that his car was recovered. [redacted] arrived a few minutes later and identified numerous items in the vehicle that were not his property. In the search of the vehicle the following items were recovered a new Boost Mobile cellular phone, 2 packages of Game Leaf Cigars one empty and one unopened. One digital scale. One of the cigar wrappers with a green leafy substance rolled up in it. One small plastic Betty Crocker resalable container containing a green leafy substance weighing 16.9 grams. A CT Driver's License for [redacted] and \$148 in cash.

The green leafy substances were tested with NARC test kit #8 and tested positive for the presence of THC. A one to one show up was then conducted with [redacted] and during the one to one show up; he positively identified Kubilay Demirhan as the young man who had previously stolen his car. [redacted] stated that he was even still wearing the red shirt with the Turkish symbol on it that he had on during the theft.

At this time Demirhan was transported to the Middletown Police Department for processing. [redacted] took custody of his stolen vehicle. [redacted] then went to the Middletown Police Dept. to give this Officer a sworn written statement requesting Demirhans arrest. See sworn written statement.

Kubilay Demirhan is charged with Operation of a Motor Vehicle without a License 14-36(A)\*, Larceny 2nd Degree 53a-123, Criminal Impersonation 53a-130, Possession of Less than 1/2 oz of Marijuana 21a-279a(a)1, and Possession of marijuana paraphernalia with less than 1/2 oz of marijuana 21a-267(d)(1). Demirhan was issued a court date of 7/25/16 at 0930 hours and was held on a \$50,000.00 bond. End of report.

REMARKS

On 19 July 2016 at approximately 0200 hours, Middletown Police received a walk-in Threatening complaint at Police Headquarters.

The alleged suspect at this time was in the bathroom located in the lobby of the Police Department which is open to the public.

According to the complainant; (18 YO) the alleged suspect, later to be identified as Gary

Roundtree (52 YO) stated that he was going to get a gun and shoot up the soup kitchen and Hartford.

Officers surrounded the bathroom before opening the bathroom door and ordering Roundtree, who was holding a book bag; to drop the bag and exit the bathroom. After several commands, he complied.

Roundtree's person was searched which yielded in negative findings.

An officer searched Roundtree's book bag which contained clothing and miscellaneous items. There was no weapons and/or contraband located inside of the bag.

At this time Roundtree was escorted downstairs to the booking cells. Roundtree stated that he refused to be photographed or fingerprinted. Prior to placing him in a holding cell, Roundtree stated "Don't worry I'm going to get twenty years, I'm going to do something crazy." I asked him what he meant by this and he replied "Just wait and see."

Officer [redacted] gave a signed, sworn written statement which as follows:

"On July 19, 2016 myself and my friend [redacted] were walking back to my car, parked in front of the Pickle Stand on Main Street. As we got into the car a black male approached us, stood within the door jamb of the passenger side, and asked us for \$15 so he could get to New Haven. We told him that we didn't have any money. He then asked for a cigarette. I gave him one and my lighter to use. He then said, unprovoked, that he was going to get a gun, a .38 caliber and "shoot all the crack heads in Middletown, the soup kitchen, the white people in the north end" as he pointed up the street. He also said that he hated all the women on Park St. in Hartford and he was going to shoot them all. He said that he wasn't going to shoot us. We left in my car, drove around and then came to the Police Department. The male had walking into the Police Department prior to us. The male party's actions and statements alarmed us and we felt he would act on them."

Based on the above facts and circumstances and then signed sworn written statement; Roundtree was consequently charged with CGS: 53a-181; Breach of Peace, CGS: 53a-61aa; Threatening 1st Degree, CGS: 29-12; Failure to Submit to Fingerprinting & Violation of City Ordinance: 7-148/192-4; Panhandling. He is being held on a \$25,000.00 surety bond and is scheduled to appear at GA:09 on 07/19/2016 at 0900 hours.

REMARKS

On 7/13/16 at approximately 0130 hours, while on patrol, I was driving southbound on Main Street in the area of Green Street. I observed a white female later identified as : wave down and approach a green 2000 Chevy Cavalier bearing CT reg 7ALKV5, on the east side of Main Street. After approaching the vehicle stood at the window for a brief period before entering the passenger side of the vehicle. I know what I observed do, to be a common method used to solicit prostitution.

I pulled into the parking lot of It's Only Natural and continued to observe the vehicle. The vehicle pulled off northbound on Main Street. I followed the vehicle. I observed the vehicle turn right on to Rapallo Avenue without using a turn signal. While traveling eastbound on Rapallo Avenue I observed the vehicle cross over the double yellow line three (3) times. I activated my emergency lights and initiated a traffic stop at the intersection of DeKoven Drive and Washington Street. The operator later identified as, Richard Ziel, continued to pull forward and turned on to Washington Street before stopping.

I exited my vehicle and spoke with Ziel. While speaking with Ziel I could detect the strong odor of an alcoholic beverage emanating from his breath. Ziel's speech was slurred. I observed two (2) plastic water bottles filled with a yellowish brown liquid. One bottle did not have a cap and was in the cup holder. The other bottle was next to the driver's seat on the center console. The bottles were photographed (see attached). Ziel first stated the liquid was "piss" but later admitted to it being alcohol. A check through dispatch revealed Ziel did not have a driver's license.

Ziel refused to take the standardized field sobriety test, but stated "you got me I'm fucking drunk".

I transported Ziel to Middletown Police Headquarters for processing. Ziel was advised of his rights at 0207 hours. I informed Ziel I would be choosing the breath test. Ziel agreed to take the test.

The first test was conducted at 0237 hours with a result of 0.1755.

The second test was conducted at 0258 hours with a result of 0.1669.

During the post arrest interview Ziel admitted to drinking earlier.

Ziel was charged with 14-227a Driving under the influence, 14-36(a) Operating without a license and 14-230(a) Failure to drive right on MSC # MC 380314. He was given a court date of 7/27/16 at GA09 in Middletown and was released on a \$500 non-surety bond.

## REMARKS

On 10 July 2016 at 0044 hours, I was dispatched to the area of Washington Street and Newfield Street for a reported Motor Vehicle Accident.

Upon speaking to one of the involved operators; Spencer Martin (      who was identified by his CT Operators License #038166202 I observed that there was an odor of an alcoholic beverage emanating from his person, his eyes were bloodshot and glossy and his speech was slurred and slowed.

I also observed that his gait was very unsteady and he was constantly swaying back and forth.

Based on the above mentioned behavior and observations, I asked Martin to submit to the Standardized Field Sobriety Tests, which he agreed to do so.

The Standardized Field Sobriety Tests which consist of the Horizontal Gaze Nystagmus test, Walk and Turn test & the One Leg Stand test were not performed to standard.

Martin was then placed under arrest at which time he openly stated that he smoked marijuana prior to operating his vehicle, however he denied drinking.

Once back at Police Headquarters, Martin was read his Notice of Rights form, which he signed. I then read Martin; verbatim Section E: Implied Consent Advisory of the A-44 form. He was given the opportunity to contact an attorney at approximately 0117 hours. I then requested that Martin provide me with a breathe test, which he refused to do so.


While in booking, Martin again admitted to smoking marijuana.


*Note that throughout the entire booking process, Martin was falling asleep and mumbling his words. He almost fell out of his seat several times.*

Martin is scheduled to appear at GA 9 on July 25th, 2016 at 0900 hours. Martin was released on a \$500.00 Non-Surety Bond. He was then informed that his operator's license is suspended for 24 hours. Upon completion of the process Martin was picked up by his father;
