Upon arrival, I spoke with \_\_\_\_\_ (complainant) who gave a sworn written statement about this incident.

\_\_\_\_\_ stated he was directed to repossess a 2012 Ford F-250 bearing CT Combination 7347CE from 185 George Street. \_\_\_\_\_ / located the vehicle and began to tow the vehicle from the property. \_\_\_\_\_ stated while driving on George Street, he noticed the brake lights on the truck come on and the truck start up. \_\_\_\_\_ stated the Ford truck accelerated, popped off of the lift on the tow truck and drove up onto the opposite side of the yard of 185 George Street. \_\_\_\_\_ stated the truck traveled through the back yard and back onto George Street towards Washington Street nearly striking a car. \_\_\_\_\_ stated the truck

then drove onto Washington Street where it almost struck a semi truck and continued into the parking lot of Verizon Wireless, almost striking a guard rail. The truck circled back to George Street and stopped in the rear of 185 George Street.

stated he noticed the lift piston on the rear of his tow truck had been damaged, with a replacement cost of approximately \$500.00.

Dominic Dimauro (Suspect) stated he ran after the truck, jumped into it while it was being towed, and drove it off of the tow truck. I asked Dominic if he drove the truck to Washington Street and he stated, "I don't remember."

Dominic stated that his grandfather owns the truck but he uses and makes the payments on the truck.

Dominic was transported to Middletown PD where he was processed for his arrest. The Standardized Field Sobriety Tests were performed at Middletown PD and Dominic passed all three tests without incident.

Dominic was charged in violation of C.G.S. 53a-116, Criminal Mischief Second Degree, 14-222, Reckless Driving. Dominic was released on a \$5,000.00 non-surety bond and is schedule to appear at Middletown Superior Court, GA-09, on Tuesday, 06/07/16.

**REMARKS**

On 05/27/16 at 9:36 p.m., I, Officer Ortiz along with fellow officers, Froberg, Remotti, DiMassa and Bloom were dispatched to the area of Liberty St. and Pearl Street on a reported large group of males that are ready to fight.

Upon arrival, we encounter a large group of high school age males and females sitting on the porch of 188 Pearl St. Some in the group began walking away as we arrived.

The aforementioned officers parked our cruisers in front of the residence of 188 Pearl St. and we exited our cruisers.

Belin exited the apartment and immediately began yelling profanity at us in a loud tone of voice. Belin was saying, "fuck the police, fuck you mother fuckers, suck my fucking dick, you ain't shit without that badge, fuck you fucking pigs." We did not say or do anything to warrant that kind of reaction from Belin.

Belin continued yelling obscenities toward us, "fuck you fucking pigs, suck my dick mother fucker." Belin's behavior continued and it didn't appeared that he was going to stop or leave. It was to the point, where other residents were exited their home to see what was going on.

Belin did leave the area after several of his friends grabbed him and walked him away. However, about five minutes later, Belin returned and continued "mother fucking" the police as he stood in the middle of the street.

I gave Belin numerous opportunity to leave. Belin forced me to take action against him due to his behavior. I informed Belin that he was under arrest. Belin complied and he was taken into custody and transported to police lockup.

It should be noted that I later spoke to the resident across from said address, \_\_\_\_\_ said that she came out of her house because she heard someone yelling profanities. \_\_\_\_\_ said it upset her more because her four year old child was repeating what Belin was saying.

Belin, a convicted felon, was processed and is currently being held in police lockup on a \$10,000 surety bond on the charge of breach of peace 2nd degree, 53a-181. Belin will be presented to GA9 on the morning of 05/31/16.

## REMARKS

On 5/30/16 at approximately 1730hrs I (Officer Wasilewski) was dispatched to the area of 50 Ferry Street along with several other Officers for a report of 20 or more people smoking marijuana in the area. A short time after the initial report central dispatch received a second call that about 4 of the people were now fighting.

Officer Lemieux and I arrived on scene first. As I approached the group of 20-30 people I saw two black males, who I know through prior Law Enforcement interactions as \_\_\_\_\_ and Denzel Teart.

When I approached \_\_\_\_\_ and Denzel Teart they were standing apart from one another. As they saw me approach they walked toward each other, brought their hands together toward their inner waist, and got face to face at which point their chests were touching. They then quickly separated and walked toward a nearby vehicle. Their bodies were slightly turned blocking my view but it was apparent they had just

conducted some sort of hand to hand transition of an object.


Through my training, experience, and knowledge of these parties, I had suspected that they could have attempted to hide a weapon or illegal substance. Denzel Teart then leaned into the silver Chrysler 300 vehicle parked on Ferry Street directly in front of them. He leaned toward the center console and quickly exited the vehicle. I took hold of both \_\_\_\_\_ and Denzel with each hand and told them not to move. While standing beside the vehicle I detected the strong odor of marijuana emanating from the vehicle. I then asked Denzel if he had any marijuana on him or in the car. Denzel replied "I don't know nigga! I like to smoke weed. So what!"

I then conducted a search of Denzel's person for any illegal substances such as marijuana or a possible firearm. In Denzel's rear right pocket was a small white pill. The pill was inscribed with the capital letter "V" on one side and "4008" on the other side. I researched the pill on my cell phone using the "Drugs.com" app. The pill was shown to be a 1mg Lorazepam pill which is listed as a schedule 4 controlled substance with "potential for abuse" and requires a prescription under the Controlled Substance Act. A subsequent search of \_\_\_\_\_ person turned up negative for any controlled substances, marijuana, or weapons.


I then conducted a search of the Chrysler 300 which I saw Denzel quickly reach into. When I saw Denzel reach in he placed something in the center console cup holder. When I looked, the cup holder contained a small amount of marijuana the approximate size of a 1" diameter ball. The marijuana was found to weigh 1.25 grams and tested positive.

Denzel Teart placed under arrest and charged with violation of CGS 53a-167a Interfering, 21a-279c Possession of a Controlled Substance, and 21a-279a(a)(1) Possession of Less than 1/2 Ounce Marijuana. He was released on a \$5,000 Surety Bond and assigned a court date of 6/15/16 at 0900hrs.
