


After speaking to the victim and an independent witness who observed the events, I learned Davidson approached the tow truck and grabbed the victim/ operator by the shirt and neck with both hands restricting his movement and holding him against the seat. Davidson was screaming at the victim, "you just dragged my wife" and as he held _____, Davison instructed his son _____ to go into the house and get a shotgun. _____ said no. After several request to let go, Davidson did let go but only after _____ reached for a flashlight.

Based on the above facts and circumstances, Edward Davidson was placed in handcuffs which were checked for tightness and double locked. He was put in the back of a patrol vehicle and transported to police headquarters without incident. He was advised of his constitutional rights at 2103 hours, was photographed, fingerprinted, and processed under UAR# 8872758. Davidson was charged with Breach of Peace 2nd Degree; 53a-181 and Unlawful Restraint 2nd Degree in violation of C.G.S. He was held in lieu of a \$20,000 surety bond and assigned a G.A.-9 court appearance date of 3/14/16. No further police action will be taken at this time. Case closed.

REMARKS

On March 11, 2016, at approximately 0802 hours, I was dispatched to the parking lot of Woodrow Wilson Middle School (1 Wilderman's Way), for a report of a repossession driver attempting to collect a vehicle and the owner refusing the leave the vehicle.

When I arrived on scene I observed a black tow truck, bearing CT Commercial Reg L23679, parked directly behind a white Chrysler Sebring, bearing CT Reg 255ZNL parked in a handicap stall. The tow truck, which had "Cross Boom Recovery" labelled on the side, was parked perpendicular behind the Sebring

allowing it no space to move backwards.

I spoke to the owner of Cross Boom Recovery, Charles Marano (48). Marano said he was driving through the parking lot when his plate reader got a "hit" on the Sebring license plate which identified the Sebring as a vehicle wanted for repossession. I later found evidence in the contrary. Marano said the owner of the vehicle, _____, was refusing to get out of the driver's seat so he could tow the car.

It was determined we could not forcibly remove an occupant from a vehicle in order for a two company to repossess a vehicle. Through our investigation, it was discovered that Marano stood in between _____ and her driver's side door, not allowing _____ to close the door while he was in close proximity to her and frightening her. At one point _____ stated Marano reached across her body and tried ripping the keys out of the ignition and her hand as both fought for control over the keys. I was able to confirm this sequence of events from an exterior Woodrow Wilson Middle School camera. Marano used enough force that the entire vehicle shook back and forth.

It was determined the key Marano ripped out of the ignition was bent as a result of his actions, which took multiple attempts to straighten in order for the vehicle to be started and transported off scene.

Central Dispatch advised me Marano's license was expired as of March 10, 2016.

Marano was consequently issued a Misdemeanor Summons Complaint (MC 330291) for violating 53a-182, Disorderly Conduct, 53a-117, Criminal Mischief in the Third Degree and 14-12(a), Failure to Renew License. He was issued a court date of March 23, 2016 at GA9 for 0900 hours.



REMARKS**Domestic Violence Arrest**

On 3-12-16 at 1333 hours, Officer Maio and I were dispatched to an address in Middletown, Ct for a Domestic Incident.

Upon arrival on the scene, Victim stated that she has a Protective Order against her ex husband, Mr. Albrincoles. It states NO CONTACT and to stay 100 yards from her as well. Per the order she is to drop their 2 year old daughter off to Mr. Albrincoles sister, at 1100 hours at 273 Woodbury Cir so that he can have a supervised visit with the child with his sister supervising.

Victim stated that when she arrived at 273 Woodbury Cir at 1115 hours and knocked, Mr. Albrincoles opened the door. She was shocked by this, knowing he is to have no contact with her, and stepped backwards with the child and asked "where's your sister?". She stated that Mr. Albrincoles leaned forward in an attempt to take the child from her and stated "give me my damn baby!" Victim pulled further back and

again asked where his sister was. Mr. Albrincoles leaned back into the door and yelled upstairs to his sister. He called Victim a bitch and then yelled to his sister "I'm going to fuck this bitch up!" Victim stated that she was in fear at this point. She stated that the sister came down, as Mr. Albrincoles was still swearing at her and she gave the sister the child and left to go home.

She was due to pick the child up at 1400 hours. Officer Maio and I responded to 273 Woodbury Cir with her. Mr. Albrincoles was still there. He stated that he did open the door and is aware of the NO CONTACT Protective Order but did not think he was violating it.

Victim drops the child off often and Mr. Albrincoles always stays up stairs and makes no contact with her. Mr. Albrincoles denied making any comments to Victim and stated that he did not say he was going to fuck her up. I asked his sister about the comments. She intentionally closed her mouth and gave Mr. Albrincoles a look that seemed to mean "you know you were wrong". He nodded at her and put his head down.



He was processed on the charge of Violation of a Protective Order and released on a \$10,000.00 non-surety bond with a court date of 3-14-16 in GA 9. 




On 03/12/2016 at approximately 0147 hours, I, Officer Santostefano responded to an undisclosed address on Silver St. for a reported active domestic.


Prior to my arrival dispatch informed me Victim #1 reported she was hit by the offender and that he ripped the front of her shirt in attempts to keep her in the apartment. Dispatch further informed me the offender had taken the telephone out of Victim #1's possession interfering with the emergency call.

The offender was later identified by his CT Driver's licence as Luis Rodriguez whom dispatch informed me had a protective order with Victim #1 as the protected party which listed CT01 which states: "...Do not assault, threaten, abuse, follow, interfere with or stalk the protected person...".

I did not observe any evidence of apparent injury to Victim #1; However, through my investigation, sworn written statements, witnesses on scene, violation of the active protective order, and dispatch's reports Rodriguez was arrested and transported to Middletown Police Headquarters for processing.

Rodriguez held on a \$20,000.00 dollar cash/surety bond for the following charges: 53a-61; Assault 3rd, 53a-96; Unlawful Restraint, 53a-183b; Interfering with an Emergency Call, and 53a-110b; Violation of a Protective Order. Rodriguez was issued the next available court date of 03/14/2016 at 0900 hours at G.A #09 located on #01 Court St. Middletown, CT 06457.
