On March 3, 2016 at approximately 0225 hours, Officers responded to an apartment building on Washington St for a reported disturbance.

Upon arrival, Officers were met by the Victim, who stated her roommate, Curtissa Solana Cofield-Rivera broke down her bedroom door. Cofield-Rivera stated the Victim owed her between \$1000 and \$1500 for past due rent and utilities, which Cofield-Rivera had paid for.

Officers observed pieces of the Victim's bedroom door, on the floor. There was also a large hole in the door, near the doorknob. The Victim stated Cofield-Rivera was attempting to break down the bedroom door. When she got through the door, Cofield-Rivera continued yelling at the Victim. Concerned for her safety, as well as her guests', the Victim called 911.

Cofield-Rivera was handcuffed, searched and transported to Middletown Police Headquarters for processing. Cofield-Rivera is being charged with violating C.G.S. 53a-182 Disorderly Conduct. Cofield-Rivera was fingerprinted and photographed during the arrest process. Cofield-Rivera was released on a \$500 non-surety bond, and is scheduled to appear at GA9 on March 3, 2016 at 0900 hours.

REMARKS

On 2/26/16 at approximately 1532 hours Middletown Police were dispatched to #888 Washington St. (Advanced Auto Parts department store) for a report of a male party having fraudulently used a debit card to attempt to purchase store items, while a second associated party left the scene possessing an unpurchased item.

Upon arrival I interviewed the accused party, a Robert Mcwhite Jr. (46 y/o), who, after interviewing the witness and store manager, as well as viewed store merchandise and receipts of failed purchases,

established that Mcwhite was in possession of, and made failed attempts at, using a fraudulent TD Bank Debit Card with a female name on the front. Mcwhite entered the store with a second unidentified suspect. This second suspect exited the store with a piece of merchandise valued at \$500.00 (Manifold Converter), just prior to when the checkout register declined the processing of the transaction. At this approximate time the manager on duty/witness realized that the debit card did not belong to the customer using it (Mcwhite).

Mcwhite stated that he believed that the card he was tryign to use was legal and valid. The purchase was denied numerous times. The on duty manager, who witnessed the incident and was in charge of processing the fraudulent debit card transaction provided a sworn written statement.

The fraudulent debit card was later deemed by a TD Bank employee to be a fraudulent account number, not stolen.

The accused claimed he had "no clue what was going on" throughout the duration of the incident.

Based on the testimony of the accused of Mcwhite (having entered the store with the "De-co" suspect who left with the Manifold Converter), the sworn written statement of the witness manager, the documentation (receipts) showing which items were rung up to be purchased, the physical Debit Card in the possession of Mcwhite with the female name on it (I identified Mcwhite with picture ID), it was reasonable to believe that Mcwhite intended to agree with the second unknown actor to engage in the performance of the crime of Larceny (5th Degree) and Illegal Use of Credit Card.

I issued Mcwhite a Misdemeanor Summons #MC 228083 for 53a-128d; Illegal Use of Credit Card, and 53a-48 to 53a-125a; Conspiracy to Commit Larceny 5th Degree. The item stolen was totaled at \$500.99. Mcwhite was issued a court date of 3/11/16 at GA-09 at 0900 hours.

On arrival I observed a male victim on the ground who would be identified as Victim #1. The victim stated that he was just assaulted by Steven Ellam inside his residence who had punched him multiple times in the head and kicked him in the ribs while he was down on the ground. I spoke to a wittiness who observed the incident who would be identified as Wittiness #1. Victim #1 was transported to Middlesex Hospital for

injuries sustained in the incident.

Witness #1 stated that he observed Ellam assault Victim #1 and then produce a folding lock blade knife with the blade extended walking towards Victim #1. Witness #1 stated that he was able to get the knife away from Ellam who fled the scene.

Ellam was taken into custody on Thomas Street and a folding lock blade knife was located on his possession in his right front pocket. Ellam was transported to Middletown Police Headquarters, read his rights, processed, charged with Criminal Attempt to commit Assault 1st 53a-49/53a-59, Disorderly Conduct 53a-182, held on a \$10,000.00 surety bond and given a court date of 03/03/2016 at GA-09.


