Therefore, I issued her M.S.C. ticket # MB 349677 for the following violations of the C.G.S. :


- Insufficient Insurance, 14-213b

REMARKS

On 07 May 2016 at approximately 0128 hours, I, a Middletown Police Officer was on routine patrol traveling southbound on Main Street approaching the intersection with Washington Street. I observed a tan Honda Accord bearing CT Reg. AC87147 make a left hand turn onto Main Street from Washington Street at a high rate of speed, causing the tired to screech. The vehicle proceeded to travel northbound on Main Street.

As I observed the vehicle in motion, I found that the operator failed to maintain in the proper lane a total of three times and failed to obey a traffic signal.

I enacted my emergency lights and siren to initiate a motor vehicle stop. The operator responded by pulling over onto the shoulder of the roadway on the Arrigoni Bridge.

I then made contact with the operator Deidra Kinlaw (23 YO), who was identified by her Connecticut Operators License #048826260. I informed her of the reasons I pulled her over. Throughout my entire interaction with Kinlaw, I observed that her eyes were bloodshot and glossy, her speech was slurred and she had an odor of an alcoholic beverage emanating from her person. Kinlaw displayed a numerous amount of behavior that led me to believe she was under the influence of drugs and/or alcohol.

Based on the above mentioned behavior and observations, I asked Kinlaw to submit to a Standardized Field Sobriety Testing, which she agreed to do so.

The Standardized Field Sobriety Tests which consist of the Horizontal Gaze Nystagmus test, Walk and Turn test & the One Leg Stand test were not performed to standard.

Kinlaw was placed under arrest and was then transported back to Police Headquarters for the booking process.

Once back at Police Headquarters, Kinlaw was read her Notice of Rights form, which she signed. I then read Kinlaw; verbatim Section E: Implied Consent Advisory of the A-44 form. She was given the opportunity to contact an attorney at approximately 0208 hours. I then requested that Kinlaw provide me with a breathe test, which she agreed to do so. The results of the tests are as follows:

Breathe Test #1: B.A.C .2001 @ 0216 hours

Breathe Test #2: B.A.C .1845 @0235 hours

While in booking, Kinlaw admitted to drinking "Captain Morgan" (Rum) at a friends house in Meriden, Connecticut. She stated that she began drinking at about 11:30pm on 05/06/2016 and stopped at about 11:45pm on 05/06/2016.

Kinlaw was issued Misdemeanor Summons Complaint #MC329623 for CGS 14-236; Failure to Drive in Proper Lane (3 counts), CGS: 14-299; Failure to Obey a Traffic Signal & CGS: 14-227a; Operating a Motor Vehicle While Under the Influence of Drugs and/or Alcohol. Kinlaw is scheduled to appear at GA 9 on May 16, 2016 at 0900 hours. Kinlaw was released on a \$500.00 Non-Surety Bond. She was then informed that her operator's license is suspended for 24 hours. Nothing further.

REMARKS

On May 8, 2016 at approximately 2339 hours I (Ofc. Terrible) was traveling in a marked Police Cruiser #1407 westbound on Washington Street near #1189.

At this time I utilized my Police Cruiser's on board MDT and ran a vehicle's Connecticut Registration Plate #352-YUC that was traveling directly in front of me. The _____ system provided vehicle information indicating the registration plate belonged on a 2004 Mitsubishi Endeavor four (4) door sedan color white. The vehicle traveling directly in front of me appeared to be a 1990 color green Honda Accord four (4) door sedan. When in a safe location to do so I activated my emergency lights and siren. The operator responded to my request and pulled off and into the shoulder of the roadway near #1189 Washington Street.

Contact was made with the operator who identified himself as Javier Lopez. Lopez was operating his recently purchased vehicle 1900 color green Honda Accord four (4) door sedan, bearing the Misuse Registration Plate #352-YUC. Dispatch attempted to identify Lopez's information from the information he provided through the _____ system, but was unsuccessful. Lopez then provided a student identification with a photograph of himself and name, but no date of birth was present. Lopez was unable to provide any State or Federal identification to prove his identity or any State documentation of the vehicle.

Based on Lopez unable to provide any State or Federal Identification information he was placed into handcuffs, checked for tightness, and double locked. Lopez was placed into the rear seat of Police Cruiser #1407 for transport to Middletown Police Department. I then removed the rear registration plate from the vehicle prior to departure.

Once at Police Headquarters Lopez was read his Notice of Rights, which he acknowledged by signing at approximately 0039 hours. He then provided a different date of birth, but still was unsuccessful in obtaining identifying information. Lopez was then photographed and fingerprinted, which provided a Uniform Arrest #8873007 and charged with C.G.S 14-147; Improper Use of Registration Plate, C.G.S 14-12(a)*; Operating an Unregistered Motor Vehicle, C.G.S 14-213b; Failure to have Minimum Insurance, and C.G.S 14-36(a); Operating Motor Vehicle w/o License. After obtaining a confirmation on Lopez's fingerprints he was provided a \$500.00 Non-Surety Bond and released pending his arraignment on May 23, 2016 at 0900 hours. Lopez was cooperative and understanding throughout the entire interaction with him. Nothing further.

REMARKS

On April 30, 2016, at approximately 2313 hours, this writer was conducting patrol in my marked Middletown Police Vehicle, traveling Southbound on Ballfall Rd.

I observed a dark colored vehicle speed out Alsace Terr, directly in front of my vehicle, also traveling Southbound on Ballfall Rd. I observed the vehicle swerving from side to side in the lane. The vehicle approached the intersection of Ballfall Rd. and Washington St. and took a right hand turn to travel Westbound on Washington St., failing to use a blinker (in violation of 14-242). Central Dispatch advised me

the vehicle, bearing CT Reg 183 WGG had an expired registration dating back to August 2015. I conducted a motor vehicle on the vehicle, which pulled over on Washington St. as it turns into Meriden Rd.

I identified the operator as Jonathan Allison (27). I could smell the odor of an alcoholic beverage emanating from the inner compartment of the vehicle. Allison said he did not consume any alcoholic beverages prior to operating the vehicle.

I conducted two pre-exit tests on Allison, one of which he failed. I conducted a series of Standardized Field Sobriety Tests (SFST's) on Allison, all of which he failed. Allison was consequently placed under arrest and transported to Middletown Police Headquarters for processing. He was apprised of his constitutional rights at 2351 hours.

I read him the A-44 Implied Consent Advisory. I advised him I would be choosing a breath test, he said he would take it without a problem. He was given a chance to call an attorney at 2357 hours and declined to make this call.

Allison's first breath test, taken on the Draeger Alcotest 9510, which I'm certified on, was given at 0009 hours with a result of .1220. The second breath test, given at 0029 hours had a result of .1146.

Allison was issued a Misdemeanor Summons (MC 330305) in violation of 14-227A (2nd Offense). Operating a Motor Vehicle Under the Influence of Alcohol/Drugs, 14-12(A)*, Operating an Unregistered Motor Vehicle and 14-242, Failure to Use a Turn Signal, the reason for the motor vehicle stop. Allison was given a court date of May 25, 2016 for 0900 hours at GA9, located at 1 Court St., Middletown, CT.




