REMARKS

On 5/22/2016 at 1902hrs, I Ofc. Sanford, was performing patrol when I observed a red Honda Civic bearing CT reg "3ATKS0" traveling Northbound on Middle Street. As the vehicle drove by me with my windows down, I detected the odor of marijuana emanating from the Civic, which was the only vehicle in the vicinity. As I traveled behind the vehicle, I continued to detect the odor for approximately 1/2 mile. I initiated a MV stop on the Civic on Middle Street. Upon making contact with the operator, identified as Michael Benson, I could again detect the odor of marijuana emanating from the vehicle. Benson stated he had been smoking marijuana as he drove by me and threw the rest of his blunt out the windows shortly before I stopped him.

Benson consented to a search of the vehicle, where I located a bag of green leafy substance. I was also informed Benson had a suspended license.


Benson was issued MSC #MC330323 for violating statute 14-215 - Operating a MV with a suspended

REMARKS

On 5/17/16 at approximately 1708hrs I (Officer Wasilewski) was dispatched to the Middlesex Outpatient Surgery Center at 530 Saybrook Road for a threatening report in which a patient threatened to come back and shoot members of the nursing staff. Upon my arrival I spoke with head nurse stated that she thought the patient (later identified as Janeen Shaw) may have been acting out because she had just come out of anesthesia. then described the incident in detail.

stated the patient (Janeen Shaw) had been brought out of her out-patient surgery and began to


"come to" after being put under with anesthesia. Shaw started to become verbally combative when the nurses asked her to remain in her bed until she became more oriented. Shaw then increased her aggression and became physically combative. She began hitting and punching staff to get them away from her. Shaw reportedly stood on the bed and began taking off her hospital gown. [redacted] stated the staff decided to just let her leave due to her increasing physical violence. Shaws husband [redacted] was already there to bring her home after the surgery. While changing her cloths, Shaw reportedly yelled throughout the large recovery room "I'm going to come back and shoot you up!" Just prior to walking out the door Shaw also stated "There are a lot of bad people in the world. Just so you know, I am one of those bad people!", further intensifying the fact that she considered herself to be a credible threat who would come back and carry out a shooting inside the hospital. I (Officer Wasilewski) explained to [redacted] that it seemed as though Shaw was coherent and aware of the detailed threats she was making, rather than acting out due to anesthesia.


[redacted] provided a voluntary sworn written statement describing the incident. In total there were seven nurses, doctors, and hospital security personnel present during Shaw's threat, not including two patients who had left prior to my arrival. I (Officer Wasilewski) asked central dispatch to check to see if Shaw or her husband had any registered firearms. I was informed that they did not.

After obtaining the statement, Sergeant Bartolotta and I (Officer Wasilewski) went to Shaw's address and spoke with her. When I approached Shaw in her driveway she immediately stated "Are you here because of what I said at the hospital? I was just really angry." After speaking to her for several minutes I saw that Shaw was becoming aggravated and did not want to talk about the incident. I asked Shaw for her ID so that I could run her name and document the incident. Shaw refused to provide her ID but when Sergeant Bartolotta ordered her to show her ID she took it out of her pocket and threw it at him causing it to fall to the ground. Shaw attempted to walk away and had to be detained in handcuffs after attempting to run inside her house. Sergeant Bartolotta instructed me that Shaw was under arrest for threatening the hospital. Shaw then yelled "I can't take this. "When I get out I am going to the Arrigoni Bridge to jump off!" Due to her suicidal statement, Hunters Ambulance was called to the scene to transport her to the Middlesex Hospital for a PEER. Once at the hospital Shaw was turned over to the hospital staff.

Shaw was issued a misdemeanor summons (MC 397044) for violation of CGS 53a-62 Threatening 2nd Degree and 53a-181 Breach Of Peace. She was assigned a court date of 6/1/16 at 0900hrs. Shaw was told she would have to appear at the GA 9 court house on that date and time. She stated she understood.



Impala bearing CT registration 6ALEA1. A check with dispatch revealed that the plate belonged on a red Dodge Neon. I activated my emergency lights and siren to initiate a motor vehicle stop for the violation. The vehicle pulled to the right and came to a complete stop. I approached the operator on the driver's side and identified him as Eliso Rivera by his Connecticut Driver's License.

Rivera stated that he was leaving the Aresco's Convenience store on Liberty Street after purchasing a few items for his daughter. Rivera openly admitted that the plate did not belong to the vehicle nor did he have insurance for the vehicle. Rivera appeared abnormally nervous and admitted to prior arrests for narcotic use. Rivera gave this Officer verbal consent to search his vehicle which yielded negative results. Rivera was allowed to leave his vehicle legally parked on Liberty Street until suitable arraignments could be made.

Rivera was issued a Misdemeanor Summons, MC 396873, for violation of C.G.S. 14-147(c) Misuse of Maker Plates, violation of C.G.S. 14-213b Failure to Maintain Minimum Insurance, and violaton of C.G.S. 14-12(a)* Operating an Unregistered Motor Vehicle. 


REMARKS



REMARKS

On May 13, 2016 around 0048 hours, I (Ofc. Froberg) was conducting a speed enforcement detail on Washington Street in the area of the intersection of Camp Street. I was utilizing Middletown Police Department laser #7 of which I am a certified operator of and was tested at the beginning and end of my shift finding it to be in proper working order both times.


I observed a black 2000 Chevrolet Blazer bearing CT marker #385YAA traveling westbound on Washington Street which appeared to be traveling faster than other traffic recently observed in the area. Utilizing the laser device the Blazer's speed was found to be 48 miles per hour, which is well over the clearly posted 35 mile per hour limit.


The Blazer was signaled and stopped just over the town line into Middlefield on Washington Street in the area of the intersection of Ball Fall Road. Sergeant Smith arrived as a backup officer a few moments later. The operator was identified as Ian Orlacchio upon presentation of a Connecticut operators license and offered the excuse that he was late to pick up his mother from work. Orlacchio admitted that his license was suspended and that the vehicle was neither registered nor insured and that he took the license plate off of one of his old cars. Orlacchio was joined in the vehicle by passenger Officer St. Peter arrived on scene as another backup officer.

During my normal line of questioning as to whether there was anything illegal in the vehicle Orlacchio admitted that there might be some marijuana and that I could check if I wanted. Both Orlacchio and were asked to step from the vehicle one at time, searched with negative results for weapons and or contraband and instructed to sit on the curb near the rear of the vehicle. A search was conducted only yielding trace amounts of what appeared to be marijuana, which was not enough to collect and or field test.

Checks of CT DMV files showed that Orlacchio's license was in fact suspended and showed no information for the marker plate. Orlacchio was advised that the vehicle would have to be towed from the scene to which he requested Midtown which was passed along to dispatch and arrived a short time later, removing the vehicle. The marker plate affixed to the vehicle was seized and placed in the marker plate bin to be returned to DMV at a later date and time.

Orlacchio was issued CT misdemeanor summons #MC379679 with a court appearance date of 5/25/2016 at GA#9 for violations of CGS 14-147(c) Misuse of marker plate, 14-215 Operating with a suspended license, 14-213b No insurance, 14-12(a)* Operating an unregistered motor vehicle and 14-218a Traveling unreasonably fast. Orlacchio and were picked up a short time later by a friend. Case cleared by arrest, nothing further.
