### REMARKS

On 5/26/16 at approximately 2139 hrs, I, Officer Tiano, was investigating a loud noise compliant in the area of Pearl Street and Grand Street.

While investigating this complaint, individuals in the area told me that there was a fight occurring down the road and began pointing to the area of Pearl Street and Liberty Street.

Upon my arrival to this area, I saw OFFENDER 1 walking quickly towards VICTIM 1 in the middle of the road on Pearl Street just north of Liberty Street. VICTIM 1 appeared to be walking away from OFFENDER 1. OFFENDER 1 then walked towards VICTIM 1 and got within inches of her face and began yelling while waving his hand towards her face. From my vantage point, it appeared that OFFENDER 1 was about to strike VICTIM 1.

In running both parties through our dispatch center, it was revealed that both parties had an active protective order. This order listed VICTIM 1 as the protected party and OFFENDER 1 as the respondent. This order listed the conditions of CT01, CT03, CT05 and CT14 and is a full no contact order of protection.

Due to actions of OFFENDER 1 I witnessed upon my arrival to the above location and the active order of protection between both parties, OFFENDER 1 violated the order of protection by arguing with VICTIM 1 in the middle of the road on Pearl Street.

At the conclusion of this investigation, OFFENDER 1 was placed under arrest and charged with the offense of C.G.S. 53a-223 Violation of a Protective Order and C.G.S. 53a-181 Breach of Peace for getting in to a verbal argument in the middle of the roadway with VICTIM 1 who he has a full no contact order of protection with.

OFFENDER 1 was issued a \$5,000 surety bond and a court date of 5/27/16 at Middletown Superior Court G.A. 9 at 0900 hrs. Due to being unable to post his bond, he is currently being held in police lockup until his court date.

REMARKS

On 13 May 2016 at approximately 0059 hours, I, a Middletown Police Officer was on routine patrol in a marked police cruiser. I was traveling west bound on Washington Street.

I observed a blue, four door Hyundai Accent bearing CT Reg. 558ZSW traveling west bound in front of me. I made a DMV Inquiry regarding that above mentioned registration plate.

Central Dispatch initially advised me that there was no record of the plate. Shortly after dispatch notified me that they found in the historical files that the plate was last registered to a 1996 Audi A4

I enacted my emergency lights and siren to initiate a motor vehicle stop in the area of Washington Street and Park Place. The operator responded by pulling over onto the shoulder of the roadway.

I made contact with the operator; Yahaira Noriega (29 YO) who was identified by her CT Identification Card #038141104. Noriega admitted that she did not have a license. She then admitted that the vehicle was her boyfriends and she did not know where any of the paper work was. I asked her if the vehicle had valid insurance and Noriega stated that she was unsure.

Noriega was consequently issued a Misdemeanor Summons and Complaint ticket #MC379768 for CGS: 14-147c; Misuse of Registration Plates, CGS: 14-12a\*; Operating an Unregistered Motor Vehicle, CGS: 14-213(b); Failure to Maintain Minimum Insurance & CGS: 14-36(a); Operating a Motor Vehicle without a License. She was given a court date of May 27, 2016 at 0900 hours located at GA:09. Nothing further.



I ran the VIN through [redacted] and confirmed that there were no hits. I also confirmed that Rivera-Rodriguez had no operators license.



## REMARKS

On 05/27/16 Ofc. Foster and I were dispatched to the area of 334 Plaza Drive for a complaint of suspicious activity. The complainant, [redacted], told Central Dispatch that a co-worker was stalking him and was currently at his location. Upon arrival Ofc. Foster spoke with [redacted] while I spoke with his co-worker, later identified as Erika Wetteman.

[redacted] stated that at approximately 2230 hours that evening he had gotten out of work from Adelbrook Behavioral and Developmental Services in Cromwell, but had stayed a little later to watch a basketball game on TV while there.

"I noticed that my co-worker Erika Wetteman was waiting outside in her vehicle (at work). Erika did not work tonight and had no reason to be at work. I left a short time later and went to my girlfriend's house on Plaza Drive at about 0215 hours. When I pulled into the complex I observed Erika in her vehicle in a visitor's spot. Erika had previously vandalized my vehicle..."

[redacted] explained that Wetteman must have followed him to that location on Plaza Drive because there was no way that Wetteman knew where his girlfriend lived. He further stated that his girlfriend had recently given birth to their child and was afraid for their safety. [redacted] stated that he had filed a police report about a

week ago regarding a similar stalking incident, with Wetteman as the offender. In that police report, Ofc. Bak instructed Wetteman to cease contact with \_\_\_\_\_ outside of work or should could be subject to arrest. Refer to case file #16-12279 for further information regarding that case. \_\_\_\_\_ provided a sworn written statement attesting to the above facts, which was scanned and electronically attached to the case file.

Wetteman was seated in her vehicle further up Plaza Drive from #334 during our conversation. Wetteman stated that she currently resided in Killingworth but had been visiting a friend on Miner Street in Middletown and was headed home. When asked how she ended up on Plaza Drive, Wetteman stated that she had pulled over to use the phone. When I told her that it was a bit odd that she had pulled over in an apartment complex that was out of the way, and clearly not on her way home, Wetteman continued to adjust her car radio and play video games on her cellphone. Wetteman further refused to provide a contact phone number for the unidentified friend that she was allegedly visiting, which could be used to corroborate her story. Wetteman stated that she had called her husband when she pulled over in the visitor's parking spot, but later admitted that was a lie. Wetteman further admitted that she knew no one who lived on Plaza Drive and had no other reason to be there, and was often evasive and short with her explanations.


Wetteman was placed under arrest and transported to Middletown Police Headquarters for processing. Wetteman was charged with Stalking in the 3rd Degree (C.G.S. 53a-181e) and held on a \$5000 cash/surety bond pending arraignment on 05/27/16 at 0900 hours.



Officer Foster provided Mark Dickinson a ride to the Wesley Inn and Suites on Washington Street where Dickinson rented a room for the night.


