He was also reported to be yelling profanity at random people and was heavily intoxicated.

I arrived with Officer Haddad. Hoffman was heavily intoxicated. When asked for his identification he told Officer Haddad to "fuck off" and "go fuck yourself" several times. I asked for his identification and he balled his fists at me and stated "ok tough guy! Let's go!" and made an attempt to come at me. I spun him around and handcuffed him with minor resistance.

Due to his level of intoxication, he could no longer stand on his own and was babbling incoherently. He was transported to Middlesex Hospital for detox and released on an MSC for Breach of Peace 2nd, Interfering

With an Officer, and VCO Drinking In Public with a court date of 9-21-16 in GA 9.
