REMARKS

On 8-31-16 at approximately 10:08hrs this officer was dispatched to the area of #6 Longworth Avenue, for the report of an evading accident. Dispatch further informed this Officer that the victim of the collision had followed the evading vehicle directly to Longworth Ave. While in route to Longworth Ave, Officers Stroud and Bloom, stated over the radio that they had been approached in the area of Main and Liberty, by the operator of a third vehicle. The operator was also stating that her vehicle was struck on Washington St. by the evading vehicle. The evading vehicle was described by both victims, as a black Hyundi Tucson with the Connecticut registration plate of AA62939. The vehicle would later come back as registered to a Florence Dimouski.

This officer met with both victims, who positively identified Dimouski's vehicle as the vehicle who struck their cars. The fresh damage to Dimouski's vehicle also matched up to the damage sustained to the victims vehicles. Dimouski would also later state that she "just bumped them".

Due to the facts and circumstances mentioned above, Dimouski was issued Misdemeanor summons #MC 397182 for the charges of 14-224 Evading responsibility, and 14-230a Failure to drive right. Dimouski was given a court date of 9-13-16 at GA#9. End.

REMARKS

On 8/20/16 at approximately 0315hrs Officer Terrible and I (Officer Wasilewski) were completing a motor vehicle stop in the area of Smith Street and Industrial Park Rd. As we were getting in our vehicle to leave, a blue Acura bearing CT registration 5ANND3 traveled past our vehicles at a high rate of speed while our

*emergency lights were still activated. The Acura continued westbound on Smith Street toward Middle Street.

We completed the motor vehicle stop and drove westbound toward the vehicle. We observed the Acura make a quick stop at the intersection then travel northbound on Middle Street. We accelerated to close the distance between our vehicles but when he turned onto Middle Street, the Acura had actually gained distance clearly accelerating in an attempt to get away. I accelerated our marked Police Cruiser and activated our emergency lights and siren while trying to catch up to the vehicle. We closed the distance about 1/8th of a mile north of the intersection of Middle Street and Smith Street. The vehicle came to a stop on Middle Street by Bradley Street.

As Officer Terribile and I exited our cruiser and made contact with the two occupants (Later identified as) and (identified as Jhakur West). As we were approaching the vehicle we observed both occupants attempting to switch seats. West was operating the vehicle and attempted to switch seats to the front passenger side while got in the driver seat. While standing by the driver door I was able to detect the odor of marijuana emanating from the interior of the vehicle.

After running both ind West through central dispatch we were advised that had a valid license. However, West's license was suspended. West then admitted that his license was suspended because he did not pay an infraction. When asked if he had any marijuana in the vehicle, he stated he "might have a little" in the car. A subsequent search of the vehicle revealed a clear plastic sandwich baggie which was twisted and tied shut at the top which was located in the center console. The baggie contained 2.29grams of a brownish green bud like substance which, through my training and experience, I was able to identify as suspected marijuana. Also inside of the vehicle was a clear plastic baggie containing 12 smaller 1"x1" ziplock baggies. All of the 12 bags were empty. Through my training and experience I am aware that the small ziplock baggies are used to sell smaller amounts of marijuana on the street. The marijuana and baggies were later seized and brought to the Middletown Police Department where they were tagged for destruction.

West was issued a misdemeanor summons (MC 380384) for violation of CGS 14-215 Operating with a Suspended License, 21a-279a(a)(1) Possession of Less than 1/2 ounce Marijuana, and 14-218a Traveling Too Fast. He was given a court date of 9/6/16 at 0900hrs and told he would have to appear at the GA 9 court house on that date and time. He stated he understood.

REMARKS

On the above date and time, units were dispatched to an address in Middletown CT for a disturbance.

Kristina Kroll was involved in a heated verbal argument with her roommate, Victim 1. Victim 2 recorded the incident on her cell phone capturing Kroll yelling and being aggressive when dealing with the victims. On video, Kroll stated " I have three sisters, let me know a time and place." She made this comment to V2 who was recording the incident at the time.

Kroll was observed yelling at each of the victim's, as well as Witness 2. Kroll appeared to be the aggressor and each party on scene verified this.

Sgt Baboolal took a sworn written statement from V1 on the incident. In her statement she adds that this has been an ongoing issue, and that Kroll threatened to come back to the residence after she moves out,

and " beat her ass, and put her in the hospital." V1 stated that Kroll said this statement previously as well as 8/31/16 and 9/1/16.

Kroll was issued a Misdemeanor Summons (MC378588) for Breach of Peace 2nd 53a-181 and Threatening 2nd 53a-62. She was released on scene and issued a court date of 9/2/16 at 0900 hrs due to the domestic related violations. She was also issued a copy of the Conditions of Release form (which she signed) that had boxes 1,4,5 checked off.

REMARKS

On 08/17/2016 at approximately 14:48 hours I, Officer Austin Smith was operating a marked police cruiser southbound on East Street in the area of Miner Street.

At that time I observed a gray Honda Accord drive through the stop sign on Miner Street almost striking the vehicle traveling ahead of me. The vehicle ahead of me had to apply their brakes and swerve across the double yellow line into the oncoming lane to avoid a collision. I then activated the emergency lights and siren on my vehicle and caught up to the Honda to conduct a traffic stop. The Honda pulled over at the


intersection of East Street and Briarwood Lane.

The Honda was bearing CT registration AC25088. I identified the operator of the vehicle as Sarina Hunt. Hunt acknowledged that she saw the vehicle that she almost stuck, but that she was in a hurry and thought she had time to make it. A check of Hunt's license revealed that it had expired on 02/11/2016 and that she was now operating without a license. I asked Hunt for her registration and proof of insurance. She provided a valid registration certificate for the vehicle, but stated that she did not have proof of insurance. Hunt stated that she recently switched to "Go Auto Insurance," but had no documentation. I attempted to verify her coverage via telephone, but could not reach a live representative at the insurance company.

Sarina Hunt was subsequently issued Misdemeanor Summons #MC379687 and charged with violating CGS 14-213b Failure to meet minimum insurance requirements, 14-36(a) Operating without a license, and 14-301 Failure to obey a stop sign. Hunt made arrangements to have the vehicle towed privately. Hunt was released on a promise to appear and scheduled to appear at GA09 Middletown on 09/02/2016.


