REMARKS

On 9/22/16 at approximately 18:45 hrs, Officer Terribile and I, Officer Tiano, were conducting a property check of the apartment buildings of Warfside Commons located on Ferry Street on foot and clearly identifiable in police uniforms.

While approaching the alley way between 80 Ferry Street and the rear of 560 Main Street, we saw a black female standing in front of a male, who was seated on the bottom of a stair case. The male was identified as the accused,

At this time, the female involved had been seen concealing an item inside of her waist band, which she later admitted to be a substance that she was attempting to sell and misrepresent as crack cocaine to the accused.

When both parties were detained, the accused had consented to be searched at which time a small, knotted off plastic bag containing a hard, off white, rock like substance was discovered in his left pant pocket. Due to my training and experience as a Police Officer, I immediately recognized this substance as crack cocaine. The accused would later provide a sworn written statement admitting to buying the crack cocaine earlier in the evening and forgetting it was still contained inside his pocket.

The suspected crack cocaine the accused had possessed was weighed and tested. Weighing .5 grams the substance tested positive for the presumptive presence of cocaine using NARK kit #4.

At the conclusion of this investigation, the accused was charged with the offense of C.G.S. 21a-279 Possession of Narcotics (crack cocaine). He was booked, photograph, fingerprinted and received a \$5,000 non-surety bond and a court date of 10/6/16 at Middletown Superior Court G.A. 9 at 0900 hrs.

The accused was later released on this non-surety bond after signing his criminal appearance bond paperwork.

REMARKS

On September 22, 2016 at approximately 1845 hours I (Ofc. Terribile) and Ofc. Tiano were foot patrolling Ferry Street in marked Police Uniforms.

At this time we approached the ally adjacent to #80 Ferry Street and noticed a black female and black male engaged in suspicious behavior. The black female we know through our previous Police encounters as Shirley Jenkins immediately lifted her shirt and tucked an unknown item into her waist band. I know through my previous Police encounters that Jenkins is commonly in possession of contraband and has a significant criminal history of possession of contraband.

Immediately upon engaging in conversation with the individuals Jenkins stated she had contraband in her possession. When I inquired about the item tucked into her waist band, she provided me with a small color white hard substance. Jenkins then stated she and another unknown subject approached

(other individual we observed and were speaking with) and attempted to sell the substance as a representation of Crack Cocaine. Jenkins was unable to provide an further information on the unknown subject who was also involved in the attempted sale.

Upon request Ofc. Del'Mauro and his Narcotic K-9 Killian arrived on scene to provide person searches of each individual. While K-9 Killian performed such seach of Jenkins person he alerted on Jenkins bra at which time she stated additional narcotics were present on her person. Jenkins then retrieved a clear glass smoking device with Crack Cocaine residue from her bra and provided me with the item. Jenkins then spit another color white hard substance onto the ground from her mouth. The item was also seized for testing.

Jenkins was then transported to Middletown Police Department for the booking process. Once at Police Headquarters Jenkins was read her Notice of Rights, which she acknowledged by signing at approximately 1925 hours. Jenkins was then photographed, fingerprinted, and charged with C.G.S 21a-267(a); Possession of Drug Paraphernalia and C.G.S 21a-268; Misrepresentation of Contraband. She was issued a Uniform Arrest #8873523 and released on a \$5,000.00 Non-Surety Bond with a scheduled G.A #9 Court Appearance Date of October 6, 2016.

The seized items were then tested using a NARK Test Kit #10004, which tests for Cocaine/Procaine/Tetracaine/Methadone by providing brilliant blue flaky color as indicative of positive presence. After testing such items the clear glass smoking device provided the above stated positive results. All items seized were photographed, labeled, heat sealed, and placed into Middletown Police Department Evidence Locker #1. Nothing further.
