REMARKS

On 9/3/16, at approximately 11:30 hours, I, Officer Foss-Rugan along with Officer Remotti and Sgt. Lukanik responded to # 562 Main Street second floor on a police medical assist call. It was reported that an intoxicated white male was on the second floor with a head laceration. Middletown Fire Department along with Hunter's Ambulance also responded to the scene.

The accused was located inside his apartment with the victim in this case with an apparent wound to his forehead. Upon running both the victim and the accused for hits, it was learned that there was an active civil protective order in place which listed the accused as the responded and the victim as the protected person.

The order states the following: Surrender or transfer all firearms and ammunition, CT01- Do no assault, threaten, abuse, harass, follow, interfere with, or stalk the protected person, CT03- Stay away from the home of the protected person and wherever the protected person shall reside, CT05- Do not contact the protected person in any manner, including by written, electronic or telephone contact, and do not contact the protected person's home, workplace or others with whom the contact would be likely to cause annoyance or alarm to the protected person. The order was signed by the Honorable Judge Vitale and expires on

10/26/16.

The accused signed a medical refusal with Hunter's Ambulance. At that time, the accused was placed under arrest for the violation of the civil protective order. The accused admitted that he and the victim have been staying in the same apartment together.

The accused was charged with 53a-223c- Criminal Violation of a Civil Protection Order. The accused was held at Middletown Police Department on a \$75,000.00 surety bond and will be arraigned at Middlesex Superior Court on 9/6/16 at 09:00 hours.

REMARKS

On 8/21/2016, at approximately 1936 hours I, Officer Foster, was traveling Southbound on Main Street in a marked Middletown Police cruiser. Traveling in front of my cruiser was a blue Chev. Tahoe, bearing CT registration TAHOE4, with a broken windshield. I activated my emergency lights and siren to initiate a

motor vehicle stop for the violation. The operator was later identified as Zachary Colonghi by his Connecticut Driver's License.


Colonghi explained that he was unsure of how the windshield had broke, but recalled that it happened two weeks ago. While engaging Colonghi in conversation, I could smell the strong presence of freshly burnt marijuana coming from the vehicle and his person. I asked Colonghi to exit the vehicle and questioned whether or not there was marijuana on his person or in the car. Colonghi produced a glass smoking pipe from a pocket which contained marijuana residue. This was later confirmed by utilizing NARK kit #8 which yielded positive results.

A search of Colonghi's vehicle resulted in a second glass smoking pipe found behind the driver's seat which contained suspected marijuana residue. In addition, on the passenger seat, I located a balisong switch blade with an approximate three inch blade. Lastly, I located in the center console two green and white capsules with markings "E615". Colonghi was unable to name the type of medication it was but stated it was prescribed to him. I was unable to positively identify the medication.

Base on the evidence found, Colonghi was advised he was under arrest and was transported to Police HQ for processing. Colonghi was charged with violation of C.G.S. 29-38 Weapon in a Motor Vehicle, violation of C.G.S. 21a-256 Drug Not Contained in Original Container, violation of C.G.S. 21a-267(d)(1) Possession of Marijuana Paraphernalia, and violation of C.G.S. 14-99(f) Defective Windshield. Colonghi was released on a \$5000 non-surety bond and was issued a court date at GA9 on September 6, 2016 at 0900 hours

REMARKS**Arrestment Report**

That on 09/03/2016, at approximately 14:08 hours, the arrestee Mr. Tate, Winston (age 45) was operating a grey Mazda 3 baring CT maker / registration # 423-ZVS on Washington Street. Tate was traveling in an easterly direction on Washington Street (Rt.66) by Newfield Street.

An eyewitness, along with the victim, observed Tate pass about 4 vehicles stopped for the red traffic control signal at the intersection of Washington Street at Newfield Street, in oncoming traffic as he was attempting to make an illegal turn left onto Newfield Street.

The victim was traveling in a northerly direction on Vine Street and was attempting to turn left onto Washington Street as his traffic control signal was green. At this point, Tate collided with the victim's vehicle due to his reckless operation and sped off in a northerly direction on Newfield Street, evading the accident scene.

Moments later, Officers located the evading Mazda parked on Stoney Crest Drive. Contact was made with the driver, Tate, who was identified by his CT driver's license.

I asked Tate to exit the vehicle so that I could speak with him. Tate was not cooperative with answering questions, evasive with his answers and denied being involved in an accident.

While I was speaking to Tate, I could smell a strong odor of alcohol emanating from his person. Tate did admit to drinking but refused to answer what he was drinking and how much alcohol he drank. I then requested if he would submit to a field sobriety test and he refused.

A show-up identification was conducted on Stoney Crest Drive and the victim positively identified Tate as the operator of the Mazda who evaded responsibility. The victim gave a sworn written statement which was taken by Sgt. Lukanik and also signed a MPD Show-Up ID form.

Tate was transported to MPD HQ for processing and processed on the following violations of the C.G.S. ;

- DUI, 14-227a
- Evading Responsibility, 14-224
- Failure To Obey Traffic Control Signal, 14-299
- Driving The Wrong Way On A Divided Highway, 14-237
- Reckless Driving, 14-222
- Failure To Submit To Fingerprints, 29-12

During the booking process, Tate made alarming comments that cops are getting shot and that he has guns. Tate also provided a New Haven address, however he listed addresses out of Middletown, New Britain and said that he was homeless. Tate refused to be finger printed and refused to submit to a breath test on the intoxilizer. Tate, who claimed to be an Army veteran also refused to sign any of his arrest paperwork or be photographed.

Tate was held on a \$75,000.00 surety-bond and his scheduled arraignment with the Middlesex Superior Court (G.A.09) in on Tuesday, September 6th, 2016.



I arrived on scene and met with VICTIM 1 who stated Alicia Morse had been drinking and was out of control. VICTIM 1 stated Morse had come to bed after a party at the house and began arguing with him about unwanted guests at the house. As the argument escalated and allegedly became physical, Alicia called for house guests [redacted] and [redacted] to separate them. [redacted] and [redacted] attempted to intervene, but Alicia became upset with them and began shoving them, attempting to remove them from the house.

Alicia and VICTIM 1 separated but continued their argument verbally from the first floor to the second. Again the argument escalated and Alicia followed VICTIM 1 to the first floor and threw a water glass she had been holding at him in the kitchen. Alicia then attempted to shove the guests out of the front door yelling at them to leave. All parties involved stated Alicia had been the aggressor in the argument.


